# $q$-Deformed KP Hierarchy and $\boldsymbol{q}$-Deformed Constrained KP Hierarchy

#### Abstract

Using the determinant representation of gauge transformation operator, we have shown that the general form of $\tau$ function of the $q$-KP hierarchy is a $q$-deformed generalized Wronskian, which includes the $q$-deformed Wronskian as a special case. On the basis of these, we study the $q$-deformed constrained KP ( $q$-cKP) hierarchy, i.e. l-constraints of $q$-KP hierarchy. Similar to the ordinary constrained KP (cKP) hierarchy, a large class of solutions of $q$-cKP hierarchy can be represented by $q$-deformed Wronskian determinant of functions satisfying a set of linear $q$-partial differential equations with constant coefficients. We obtained additional conditions for these functions imposed by the constraints. In particular, the effects of $q$-deformation ( $q$-effects) in single $q$-soliton from the simplest $\tau$ function of the $q$-KP hierarchy and in multi- $q$-soliton from one-component $q$-cKP hierarchy, and their dependence of $x$ and $q$, were also presented. Finally, we observe that $q$-soliton tends to the usual soliton of the KP equation when $x \rightarrow 0$ and $q \rightarrow 1$, simultaneously.

## 1 Introduction

Study of the quantum calculus (or $q$-calculus) [1, 2] has a long history, which may go back to the beginning of the twentieth century. F.H. Jackson was the first mathematician who studied the $q$-integral and $q$-derivative in a systematic way starting about $1910[3,4]^{1}$. Since 1980 's, the quantum calculus was re-discovered in the research of quantum group inspired by the studies on quantum integrable model that used the quantum inverse scattering method [5] and on noncommutative geometry [6]. In particular, S. Majid derived the $q$-derivative from the braided differential calculus $[7,8]$.

The $q$-deformed integrable system (also called $q$-analogue or $q$-deformation of classical integrable system) is defined by means of $q$-derivative $\partial_{q}$ instead of usual derivative $\partial$ with respect to $x$ in a classical system. It reduces to a classical integrable system as $q \rightarrow 1$. Recently, the $q$-deformation of the following three stereotypes for integrable systems attracted more attention. The first type is $q$-deformed $N$-th KdV ( $q$-NKdV or $q$-Gelfand-Dickey hierarchy) [9, 16], which is reduced to the $N$-th KdV (NKdV or Gelfand-Dickey) hierarchy when $q \rightarrow 1$. The $N$-th $q$-KdV hierarchy becomes $q$-KdV hierarchy for $N=2$. The $q$-NKdV hierarchy inherited several integrable structures from classical $N$-th KdV hierarchy, such as infinite conservation laws [10],

[^0]bi-Hamiltonian structure [11, 12], $\tau$ function [13, 14], Bäcklund transformation [15]. The second type is the $q$-KP hierarchy [17, 22]. Its $\tau$ function, bi-Hamiltonian structure and additional symmetries have already been reported in [20, 21, 18, 22]. The third type is the $q$-AKNS-D hierarchy, and its bilinear identity and $\tau$ function were obtained in [23].

In order to get the Darboux-Bäcklund transformations, the two elementary types of gauge transformation operators, differential-type denoted by $T$ (or $T_{D}$ ) and integral-type denoted by $S$ (or $T_{I}$ ), for $q$-deformed $N$-th KdV hierarchy were introduced in [15]. Tu et al. obtained not only the $q$-deformed Wronskian-type but also binary-type representations of $\tau$ function of $q$-KdV hierarchy. On the basis of their results, He et al. [24] obtained the determinant representation of gauge transformation operators $T_{n+k}(n \geq k)$ for $q$-Gelfand-Dickey hierarchy, which is a mixed iteration of $n$-steps of $T_{D}$ and then k -steps of $T_{I}$. Then, they obtained a more general form of $\tau$ function for $q$-KdV hierarchy, i.e., generalized $q$-deformed Wronskian ( $q$ Wronskian) $I W_{n+k}^{q}[24]$. It is important to note that for $k=0 I W_{n+k}^{q}$ reduces to $q$-deformed Wronskian and for $k=n$ to binary-type determinant [15]. On the other hand, Tu introduced the $q$-deformed constrained KP ( $q$-cKP) hierarchy [22] by means of symmetry constraint of $q$-KP hierarchy, which is a $q$-analogue of constrained KP (cKP) hierarchy $[25,31]$.

The purpose of this paper is to construct the $\tau$ function of $q$-KP and $q$-cKP hierarchy, and then explore the $q$-effect in $q$-solitons. The main tool is the determinant representation of gauge transformation operators $[32,33,34,35]$. The paper is organized as follows: In Section 2 we introduce some basic facts on the $q$-KP hierarchy, such as Lax operator, Z-S equations, the existence of $\tau$ function. On the basis of the [15], two kinds of elementary gauge transformation operators for $q$-KP hierarchy and changing rule of $q$-KP hierarchy under it are presented in Section 3. In Section 4, we establish the determinant representation of gauge transformation operator $T_{n+k}$ for the $q$-KP hierarchy and then obtain the general form of $\tau$ function $\tau_{q}^{(n+k)}=$ $I W_{n+k}^{q}$. In particular, by taking $n=1, k=0$ we will show $q$-effect of single $q$-soliton solution of $q$-KP hierarchy. A brief description of the sub-hierarchy of $q$-cKP hierarchy is presented in Section 5 , from the viewpoint of the symmetry constraint. In Section 6, we show that the $q$ Wronskian is one kind of forms of $\tau$ function of $q$-cKP if the functions in the $q$-Wronskian satisfy some restrictions. In Section 7 we consider an example which illustrates the procedure reducing $q$-KP to $q$-cKP hierarchy. $q$-effects of the $q$-deformed multi-soliton are also discussed. The conclusions and discussions are given in Section 8. Our presentation is similar to the relevant papers of classical KP and cKP hierarchy [32, 34, 36, 37, 38].

At the end of this section, we shall collect some useful formulae for reader's convenience.
The $q$-derivative $\partial_{q}$ is defined by

and the $q$-shift operator is given by

Let $\partial_{q}^{-1}$ denote the formal inverse of $\partial_{q}$. We should note that $\theta$ does not commute with $\partial_{q}$,

In general, the following $q$-deformed Leibnitz rule holds:

where the $q$-number and the $q$-binomial are defined by

and "०" means composition of operators, defined by $\partial_{q} \circ f=\left(\partial_{q} \cdot f\right)+\theta(f) \partial_{q}$. In the remainder of the paper for any function $f$ "." is defined by $\partial_{q} \cdot f=\partial_{q}(f) \triangleq\left(\partial_{q} f\right)$. For a $q$-pseudodifferential operator ( $q$-PDO) of the form $P=\sum_{i=-\infty}^{n} p_{i} \partial_{q}^{i}$, we decompose $P$ into the differential part $P_{+}=\sum_{i \geq 0} p_{i} \partial_{q}^{i}$ and the integral part $P_{-}=\sum_{i \leq-1} p_{i} \partial_{q}^{i}$. The conjugate operation "*" for $P$ is defined by $P^{*}=\sum_{i}\left(\partial_{q}^{*}\right)^{i} p_{i}$ with $\partial_{q}^{*}=-\partial_{q} \theta^{-1}=-\frac{1}{q} \partial_{\frac{1}{q}},\left(\partial_{q}^{-1}\right)^{*}=\left(\partial_{q}^{*}\right)^{-1}=-\theta \partial_{q}^{-1}$. We can write out several explicit forms of (1.1) for $q$-derivative $\partial_{q}$, as

More explicit expressions of $\partial_{q}^{n} \circ f$ are given in Appendix A. In particular, $\partial_{q}^{-1} \circ f$ has different forms,

which will be used in the following sections. The $q$-exponent $e_{q}(x)$ is defined as follows

The form (1.7) will play a crucial role in proving the existence [20] of $\tau$ function of $q$-KP hierarchy.

## $2 \quad q$-KP hierarchy

Similarly to the general way of describing the classical KP hierarchy [36, 37], we shall give a brief introduction of $q$-KP based on [20]. Let $L$ be one $q$-PDO given by

which is called Lax operator of $q$-KP hierarchy. There exist infinite $q$-partial differential equations relating to dynamical variables $\left\{u_{i}\left(x, t_{1}, t_{2}, t_{3}, \ldots\right), i=0,-1,-2,-3, \ldots\right\}$, and they can be deduced from generalized Lax equation,

which are called $q$-KP hierarchy. Here $B_{n}=\left(L^{n}\right)_{+}=\sum_{i=0}^{n} b_{i} \partial_{q}^{i}$ means the positive part of $q$-PDO, and we will use $L_{-}^{n}=L^{n}-L_{+}^{n}$ to denote the negative part. By means of the formulae given in (1.2)-(1.6) and in Appendices A and B, the first few flows in (2.2) for dynamical variables $\left\{u_{0}, u_{-1}, u_{-2}, u_{-3}\right\}$ can be written out as follows. The first flow is

Obviously, $\partial_{t_{1}}=\partial$ and equations of flows here are reduced to usual KP flows (4.10) and (4.11) in [39] when $q \rightarrow 1$ and $u_{0}=0$. If we only consider the first three flows, i.e. flows of $\left(t_{1}, t_{2}, t_{3}\right)$, then $u_{-1}=u_{-1}\left(t_{1}, t_{2}, t_{3}\right)$ is a $q$-deformation of the solution of KP equation [39]

In other words, $u_{-1}=u\left(t_{1}, t_{2}, t_{3}\right)$ in the above equation when $q \rightarrow 1$, and hence $u_{-1}$ is called a $q$-soliton if $u\left(t_{1}, t_{2}, t_{3}\right)=\lim _{q \rightarrow 1} u_{-1}$ is a soliton solution of KP equation.

On the other hand, $L$ in (2.1) can be generated by dressing operator $S=1+\sum_{k=1}^{\infty} s_{k} \partial_{q}^{-k}$ in the following way

We can see $u_{0}=0$, and $u_{-1}=\left(\partial_{x}^{2} \log \tau\right)$ as classical KP hierarchy when $q \rightarrow 1$, where $\tau=$ $\left.\tau_{q}(x, \bar{t})\right|_{q \rightarrow 1}$. By considering $u_{-1}$ depending only on $\left(q, x, t_{1}, t_{2}, t_{3}\right)$, we can regard $u_{-1}$ as $q^{-}$ deformation of solution of classical KP equation. We shall show the $q$-effect of this solution for $q$-KP hierarchy after we get $\tau_{q}$ in next section. In order to guarantee that $e_{q}(x)$ is convergent, we require the parameter $0<q<1$ and parameter $x$ to be bounded.

Beside existence of the Lax operator, $q$-wave function, $\tau_{q}$ for $q$-KP hierarchy, another important property is the $q$-deformed Z-S equation and associated linear $q$-differential equation. In other words, $q$-KP hierarchy also has an alternative expression, i.e.,

Here (2.13) is different from the second equation in (2.7). $\phi_{i} \equiv \phi\left(\lambda_{i} ; x, \bar{t}\right)$ and $\psi_{i} \equiv \psi\left(\mu_{i} ; x, \bar{t}\right)$ will be generating functions of gauge transformations.

## 3 Gauge transformations of $\boldsymbol{q}$-KP hierarchy

The authors in [15] reported two types of elementary gauge transformation operator only for $q$ -Gelfand-Dickey hierarchy. We extended the elementary gauge transformations given in [15], for the $q$-KP hierarchy. At the same time, we shall add some vital operator identity concerning to the $q$-differential operator and its inverse. Here we shall prove two transforming rules of $\tau$ function, "eigenfunction" and "adjoint eigenfunction" of the $q$-KP hierarchy under these transformations. Majority of the proofs are similar to the classical case given by [32,33] and [35], so we will omit part of the proofs.

Suppose $T$ is a pseudo-differential operator, and

The two equations obtained above show that $\mathrm{T}_{I}\left(\psi_{1}\right)$ satisfies (3.2), so $T_{I}\left(\psi_{1}\right)$ is also a gauge transformation operator of the $q$-KP hierarchy according to Lemma 1 .

Remark 2. There are two convenient expressions for $T_{D}$ and $T_{I}$,

In order to get a new solution of $q$-KP hierarchy from the input solution, we should know the transformed expressions of $u_{i}^{(1)}, \tau_{q}^{(1)}, \phi_{i}^{(1)}, \psi_{i}^{(1)}$. The following two theorems are related to this. Before we start to discuss explicit forms of them, we would like to define the generalized $q$-Wronskian for a set of functions $\left\{\psi_{k}, \psi_{k-1}, \ldots, \psi_{1} ; \phi_{1}, \phi_{2}, \ldots, \phi_{n}\right\}$ as

Proof. The proof is analogous to the proof of the previous theorem. So it is omitted.

## 4 Successive applications of gauge transformations

We now discuss successive applications of the two types of gauge transformation operators in a general way, which is similar to the classical case [32, 34, 35]. For example, consider the chain of gauge transformation operators,

Here the index " $i$ " in a gauge transformation operator means the $i$-th gauge transformation, and $\phi_{i}^{(j)}$ (or $\psi_{i}^{(j)}$ ) is transformed by $j$-steps gauge transformations from $\phi_{i}\left(\right.$ or $\left.\psi_{i}\right), L^{(i)}$ is transformed by $j$-step gauge transformations from the initial Lax operator $L$. Successive applications of gauge transformation operator in (4.1) can be represented by

Our goal is to obtain $\phi^{(n+k)}, \psi^{(n+k)}, \tau_{q}^{(n+k)}$ of $L^{(n+k)}$ transformed from $L$ by the $T_{n+k}$ in the above chain. All of these are based on the determinant representation of gauge transformation operator $T_{n+k}$. As the proof of the determinant representation of $T_{n+k}$ is similar extremely to the case of classical KP hierarchy [34], we will omit it.

Lemma 3. The gauge transformation operator $T_{n+k}$ has the following determinant representation $(n>k)$ :

In the above lemmas, $T_{n+k}$ are expanded with respect to the last column collecting all subdeterminants on the left of the symbols $\partial_{q}^{i}(i=-1,0,1,2, \ldots, n-k) ; T_{n+k}^{-1}$ are expanded with respect to the first column by means of collection of all minors on the right of $\phi_{i} \partial_{q}^{-1}$. Basing on the determinant representation, first of all, we would like to consider the case of $k=0$ in (4.1), i.e.

It should be noted that there is a $\theta$ action in (4.4), which is the main difference between the $q$-KP and classical KP beside different elements in determinant. Furthermore, for more complicated chain of gauge transformation operators in $(4.1), \phi^{(n+k)}, \psi^{(n+k)}, \tau_{q}^{(n+k)}$ of $L^{(n+k)}$ can be expressed by the generalized $q$-Wronskian.

Furthermore, $\phi_{i}^{(n+k)}=\phi^{(n+k)}\left(\lambda=\lambda_{i} ; x, \bar{t}\right) ; \psi_{i}^{(n+k)}=\psi^{(n+k)}\left(\mu=\mu_{i} ; x, \bar{t}\right)$. Note $\phi_{i}^{(n+k)}=0$ if $i \in\{1,2, \ldots, n\}, \psi_{i}^{(n+k)}=0$ if $i \in\{1,2, \ldots, k\}$.

Proof. (1) The repeated iteration of Theorems 2 and 3 according to the ordering of $T_{I}$ and $T_{D}$ deduces

(3) According to the changing rule under gauge transformation in Theorems 2 and 3, the new $\tau$ function of $q$-KP hierarchy $\tau_{q}^{(n+k)}$ produced by chain of gauge transformations in (4.1) is

We omitted the trivial factor $(-1)^{n}$ in the last step, because it will not affect $u_{i}$ in the $q$-KP hierarchy.

Remark 3. There exists another complicated chain of gauge transformation operators for $q$-KP hierarchy (that may be regarded as motivated by the classical KP hierarchy)

that can lead to another form of $\tau_{q}^{(n+k)}$. This is parallel to the classical case of [32].
If the initial $q$-KP is a "free" operator, then $L=\partial_{q}$ that means the initial $\tau$ function is 1 . We can write down the explicit form of $q$-KP hierarchy generated by $T_{n+k}$. Under this situation, (2.12) and (2.13) become

After the $(n+k)$-th step gauge transformation $T_{n+k}$, the final form of $\tau_{q}$ can be given in following corollary, which can be deduced directly from Theorems 4 and 5 .

On the other hand, we know from (3.3) that $T_{n}$ defined by (4.2) is a dressing operator if its generating functions are given by (4.6). Therefore we can define one $q$-wave function

Comparing the fraction above of the determinant term with (4.9), we can see that they are similar, although the form of the determinant in the numerator is different. The determinant in the numerator of (4.9) can be reduced to the same form of (4.10) if the second row, divided by $z$, is subtracted from the first one, the third from the second etc.

At the end of this section, we would like to discuss $q$-effects in the solution of $q$-KP hierarchy. By direct calculation, we get that the first flow of $q$-KP is

in which $(\cdots)=\sum_{k=1}^{i-1} a_{-k} u_{-k} \theta^{-i}\left(\partial_{q}^{i-k} u_{0}\right)(i=2,3, \ldots)$, and $a_{-k}$ depends on $q$ only. We can see that

when $q \rightarrow 1$. This result shows that the variable $t_{1}$ in $q$-KP hierarchy is corresponding to the variable $x$ in KP hierarchy. So we have two global parameters in $q$-KP hierarchy, namely $x$ and $q$. In order to show $q$-effect, we will write out the concrete form of single $q$-soliton of $q$-KP equation, namely, we let $u_{-1}$ depend on three variable $\left(t_{1}, t_{2}, t_{3}\right)$ beside two parameters $(x, q)$. We consider $L^{(1)}$ generated by one step of $T_{D}\left(\phi_{1}\right)$ from $L=\partial_{q}$, and the generating function is given by

Here $\xi_{k}=\lambda_{k} t_{1}+\lambda_{k}^{2} t_{2}+\lambda_{k}^{3} t_{3}(k=1,2), B_{1}$ is real constant. Taking this $\tau_{q}^{(1)}$ back into (2.9), then (2.10), we get $q$-soliton of $q$-KP as

which is a single soliton of the classical KP when $x \rightarrow 0$. Here $\hat{\xi}_{k}=\lambda_{k} x+\xi_{k}(k=1,2)$. In order to plot a figure for $u_{-1}$, we fix $\lambda_{1}=2, \lambda_{2}=-1.5$ and $B_{1}=1$, so $u_{-1}=u_{-1}\left(x, t_{1}, t_{2}, t_{3}, q\right)$. The single $q$-soliton $u_{-1}\left(0.001, t_{1}, t_{2}, t_{3}, 0.999\right)$ is plotted in Fig. 1, which is close to classical soliton of KP equation as we analysed above. From Figs. $2-5^{2}$ we can see the varying trends of $\Delta u_{-1}=u_{-1}\left(0.5, t_{1}, t_{2}, 0,0.999\right)-u_{-1}\left(0.5, t_{1}, t_{2}, 0, q\right) \triangleq u_{-1}(q=0.999)-u_{-1}(q)$ for certain values of $q$, where $q=0.7,0.5,0.3,0.1$ respectively. Furthermore, in order to see the $q$-effects more clearly, we further fixed $t_{2}=-5$ in $\Delta u_{-1}$, which are plotted in Figs. 6-9. Dependence of $\Delta u_{-1}=u_{-1}\left(x, t_{1},-5,0,0.999\right)-u_{-1}\left(x, t_{1},-5,0,0.1\right) \triangleq u_{-1}(x, q=0.999)-u_{-1}(x, q=0.1)$ on $x$ is shown in Figs. $10-14$, and $x=0.3,0.4,0.52,0.54,0.55$ respectively. It is obvious from figures that $\Delta u_{-1}$ goes to zero when $q \rightarrow 1$ and $x \rightarrow 0, q$-soliton $\left(u_{-1}\right)$ of $q$-KP goes to a usual soliton of KP, which reproduces the process of $q$-deformation. On the other hand, Figs. 10-14 ${ }^{3}$ show parameter $x$ amplifies $q$-effects. In other word, for a given $\Delta q, \Delta u_{-1}$ will increase along $x$. However, $x$ is bounded so that $e_{q}\left(\lambda_{k} x\right)$ and $e_{q}\left(\lambda_{k} q x\right)(k=1,2)$ are convergent. This is the reason for plotting $u_{-1}$ with $x \leq 0.55$. Obviously, the convergent interval depends on $q$ and $\lambda_{k}$. We would like to emphasize that from Figs. 6-14 ${ }^{4}$ the $q$-deformation does not destroy the profile of soliton; it just similar to an "impulse" to soliton.

## 5 Symmetry constraint of $\boldsymbol{q}$-KP: $\boldsymbol{q}$-cKP hierarchy

We know that there exists a constrained version of KP hierarchy, i.e. the constrained KP hierarchy (cKP) [25, 31], introduced by means of the symmetry constraint from KP hierarchy.

With inspiration from it, the symmetry of $q$-KP was established in [22]. In the same article the authors defined one kind of constrained $q$-KP ( $q$-cKP) hierarchy by using the linear combination of generators of additional symmetry. In this section, we shall briefly introduce the symmetry and $q$-cKP hierarchy [22].

The linearization of (2.2) is given by

\partial_{t_{m}}(\delta L)=\left[\delta B_{m}, L\right]+\left[B_{m}, \delta L\right], \tag{5.1}
\end{equation*}
$$

where

$$
\delta B_{m}=\left(\sum_{r=1}^{m} L^{m-r} \delta L L^{r-1}\right)_{+}
$$

We call $\delta L=\delta u_{0}+\delta u_{1} \partial_{q}^{-1}+\cdots$ the symmetry of the $q$-KP hierarchy, if it satisfies (5.1). Let $L$ be a "dressed" operator from $\partial_{q}$, we find

$$
\begin{equation*}
\delta L=\delta S \partial_{q} S^{-1}-S \partial_{q} S^{-1} \delta S S^{-1}=\left[\delta S S^{-1}, L\right]=[K, L] \tag{5.2}
\end{equation*}
$$

where $\delta S=\delta s_{1} \partial_{q}^{-1}+\delta s_{2} \partial_{q}^{-2}+\cdots$, and $K=\delta S S^{-1}$. Therefore

\delta B_{m}=\left[K, L^{m}\right]_{+}=\left[K, B_{m}\right]_{+},
$$

the last identity is resulted by $K=K_{-}$and $\left[K, L_{-}^{m}\right]_{+}=0$. Then the linearized equation (5.1) is equivalent to

\partial_{t_{m}} K=\left[B_{m}, K\right]_{-}, \quad \delta S=K S \tag{5.3}

Let $K_{n}=-\left(L^{n}\right)_{-}(n=1,2, \ldots)$, then it can easily be checked that $K_{n}$ satisfies (5.3). For each $K_{n}, \delta L$ is given by $\delta L=-\left[\left(L^{n}\right)_{-}, L\right]=\left[B_{n}, L\right]$ from (5.2). So the $q$-KP hierarchy admits a reduction defined by $\left(L^{n}\right)_{-}=0$, which is called $q$-deformed $n$-th KdV hierarchy. For example, $n=2$, it leads to $q$-KdV hierarchy, whose $q$-Lax operator is

L_{q \mathrm{KdV}}=L^{2}=L_{+}^{2}=\partial_{q}^{2}+x(q-1) u \partial_{q}+u
$$

There is also another symmetry called additional symmetry, which is $K=\left(M^{m} L^{l}\right)_{-}$[22], and it also satisfies (5.3). Here the operator $M$ is defined by

\partial_{t_{k}} M=\left[L_{k}^{+}, M\right], \quad M=S \Gamma_{q} S^{-1}
$$

and $\Gamma_{q}$ is defined as

$$
\Gamma_{q}=\sum_{i=1}^{\infty}\left[i t_{i}+\frac{(1-q)^{i}}{1-q^{i}} x^{i}\right] \partial_{q}^{i-1} .
$$

The more general generators of additional symmetry are in form of

$$
Y_{q}(\mu, \lambda)=\sum_{m=0}^{\infty} \frac{(\mu-\lambda)^{m}}{m!} \sum_{l=-\infty}^{\infty} \lambda^{-m-l-1}\left(M^{m} L^{m+l}\right)_{-},
$$

which are constructed by combination of $K=\left(M^{m} L^{l}\right)_{-}$. The operator $Y_{q}(\mu, \lambda)$ can be expressed as

$$
Y_{q}(\mu, \lambda)=\omega_{q}(x, \bar{t} ; \mu) \circ \partial_{q}^{-1} \circ \theta\left(\omega_{q}^{*}(x, \bar{t} ; \lambda)\right) .

In order to define the $q$-analogue of the constrained KP hierarchy, we need to establish one special generator of symmetry $Y(t)=\phi(t) \circ \partial_{q}^{-1} \circ \psi(t)$ based on $Y_{q}(\mu, \lambda)$, where

\phi(t)=\int \rho(\mu) \omega_{q}(x, \bar{t} ; \mu) \mathrm{d} \mu, \quad \psi(t)=\int \chi(\lambda) \theta\left(\omega_{q}^{*}(x, \bar{t} ; \lambda)\right) \mathrm{d} \lambda
$$

further $\phi(t)$ and $\psi(t)$ satisfy (2.12) and (2.13). In other words, we get a new symmetry of $q$-KP hierarchy,

$$
\begin{equation*}
K=\phi(\lambda ; x, \bar{t}) \circ \partial_{q}^{-1} \circ \psi(\mu ; x, \bar{t}) \tag{5.4}
\end{equation*}
$$

where $\phi(\lambda ; x, \bar{t})$ and $\psi(\mu ; x, \bar{t})$ is an "eigenfunction" and an "adjoint eigenfunction", respectively. We can regard from the process above that $K=\phi(\lambda ; x, \bar{t}) \circ \partial_{q}^{-1} \circ \psi(\mu ; x, \bar{t})$ is a special linear combination of the additional symmetry generator $\left(M^{m} L^{l}\right)_{-}$. It is obvious that generator $K$ in (5.4) satisfies (5.3), because of the following two operator identities,

$$
\begin{equation*}
\left(A \circ a \circ \partial_{q}^{-1} \circ b\right)_{-}=(A \cdot a) \circ \partial_{q}^{-1} \circ b,\left(a \circ \partial_{q}^{-1} \circ b \circ A\right)_{-}=a \circ \partial_{q}^{-1} \circ\left(A^{*} \cdot b\right) \tag{5.5}
\end{equation*}
$$

Here $A$ is a $q$-PDO, and $a$ and $b$ are two functions. Naturally, $q$-KP hierarchy also has a multicomponent symmetry, i.e.

K=\sum_{i}^{n} \phi_{i} \circ \partial_{q}^{-1} \circ \psi_{i}
$$

It is well known that the integrable KP hierarchy is compatible with generalized $l$-constraints of this type $\left(L^{l}\right)_{-}=\sum_{i} q_{i} \circ \partial_{x}^{-1} \circ r_{i}$. Similarly, the $l$-constraints of $q$-KP hierarchy

$$
\left(L^{l}\right)_{-}=K=\sum_{i=1}^{m} \phi_{i} \circ \partial_{q}^{-1} \circ \psi_{i}
$$

also lead to $q$-cKP hierarchy. The flow equations of this $q$-cKP hierarchy

$$
\begin{equation*}
\partial_{t_{k}} L^{l}=\left[L_{+}^{k}, L^{l}\right], \quad L^{l}=\left(L^{l}\right)_{+}+\sum_{i=1}^{m} \phi_{i} \circ \partial_{q}^{-1} \circ \psi_{i} \tag{5.6}
\end{equation*}
$$

are compatible with

$$
\left(\phi_{i}\right)_{t_{k}}=\left(\left(L^{k}\right)_{+} \phi_{i}\right), \quad\left(\psi_{i}\right)_{t_{k}}=-\left(\left(L^{* k}\right)_{+} \psi_{i}\right) .
$$

It can be obtained directly by using the operator identities in (5.5). An important fact is that there exist two $m$-th order $q$-differential operators

$$
A=\partial_{q}^{m}+a_{m-1} \partial_{q}^{m-1}+\cdots+a_{0}, \quad B=\partial_{q}^{m}+b_{m-1} \partial_{q}^{m-1}+\cdots+b_{0}
$$

such that $A L^{l}$ and $L^{l} B$ are differential operators. From $\left(A L^{l}\right)_{-}=0$ and $\left(L^{l} B\right)_{-}=0$, we get that $A$ and $B$ annihilate the functions $\phi_{i}$ and $\psi_{i}$, i.e., $A\left(\phi_{1}\right)=\cdots=A\left(\phi_{m}\right)=0, B^{*}\left(\psi_{1}\right)=$ $\cdots=B^{*}\left(\psi_{m}\right)=0$, that implies $\phi_{i} \in \operatorname{Ker}(A)$. It should be noted that $\operatorname{Ker}(A)$ has dimension $m$. We will use this fact to reduce the number of components of the $q$-cKP hierarchy in the next section.

## $6 \quad q$-Wronskian solutions of $\boldsymbol{q}$-cKP hierarchy

We know from Corollary 1 that $q$-Wronskian

$$
\tau_{q}^{(N)}=W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)=\left|\begin{array}{cccc}
\phi_{1} & \phi_{2} & \cdots & \phi_{N}  \tag{6.1}\\
\partial_{q} \phi_{1} & \partial_{q} \phi_{2} & \cdots & \partial_{q} \phi_{N} \\
\vdots & \vdots & \cdots & \vdots \\
\partial_{q}^{N-1} \phi_{1} & \partial_{q}^{N-1} \phi_{2} & \cdots & \partial_{q}^{N-1} \phi_{N}
\end{array}\right|
$$

is a $\tau$ function of $q$-KP hierarchy. Here $\phi_{i}(i=1,2, \ldots, N)$ satisfy linear $q$-partial differential equations,

$$
\begin{equation*}
\frac{\partial \phi_{i}}{\partial t_{n}}=\left(\partial_{q}^{n} \phi_{i}\right), \quad n=1,2,3, \ldots \tag{6.2}
\end{equation*}
$$

In this section, we will reduce $\tau_{q}^{(N)}$ in (6.1) to a $\tau$ function of $q$-cKP hierarchy. To this end, we will find the additional conditions satisfied by $\phi_{i}$ except the linear $q$-differential equation (6.2).

Corollary 1 also shows that the $q$-KP hierarchy with Lax operator $L^{(N)}=T_{N} \circ \partial_{q} \circ T_{N}^{-1}$ is generated from the "free" Lax operator $L=\partial_{q}$, which has the $\tau$ function $\tau_{q}^{(N)}$ in (6.1). In order to get the explicit form of such Lax operator $L^{(N)}$, the following lemma is necessary.

## Lemma 5.

$$
T_{N}=\frac{1}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}\left|\begin{array}{cccc}
\phi_{1} & \cdots & \phi_{N} & 1 \\
\partial_{q} \phi_{1} & \cdots & \partial_{q} \phi_{N} & \partial_{q} \\
\vdots & \cdots & \vdots & \vdots \\
\partial_{q}^{N} \phi_{1} & \cdots & \partial_{q}^{N} \phi_{N} & \partial_{q}^{N}
\end{array}\right|
$$

and

$$
T_{N}^{-1}=\left|\begin{array}{cccc}
\phi_{1} \circ \partial_{q}^{-1} & \theta\left(\phi_{1}\right) & \cdots & \theta\left(\partial_{q}^{N-2} \phi_{1}\right) \\
\phi_{2} \circ \partial_{q}^{-1} & \theta\left(\phi_{2}\right) & \cdots & \theta\left(\partial_{q}^{N-2} \phi_{2}\right) \\
\vdots & \vdots & \cdots & \vdots \\
\phi_{N} \circ \partial_{q}^{-1} & \theta\left(\phi_{N}\right) & \cdots & \theta\left(\partial_{q}^{N-2} \phi_{N}\right)
\end{array}\right| \cdot \frac{(-1)^{N-1}}{\theta\left(W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)\right)}=\sum_{i=1}^{N} \phi_{i} \circ \partial_{q}^{-1} \circ g_{i}
$$

with

$$
\begin{equation*}
g_{i}=(-1)^{N-i} \theta\left(\frac{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{i-1}, \hat{i}, \phi_{i+1}, \ldots, \phi_{N}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{i-1}, \phi_{i}, \phi_{i+1}, \ldots, \phi_{N}\right)}\right) . \tag{6.3}
\end{equation*}
$$

Here $\hat{i}$ means that the column containing $\phi_{i}$ is deleted from $W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{i-1}, \phi_{i}, \phi_{i+1}, \ldots, \phi_{N}\right)$, and the last row is also deleted.

Proof. The proof is a direct consequence of Lemma 3 and Theorem 4 from the initial "free" Lax operator $L=\partial_{q}$. The generating functions $\left\{\phi_{i}, i=1,2, \ldots, N\right\}$ of $T_{N}$ satisfies equations (6.2), which is obtained from definition of "eigenfunction" (2.12) of the KP hierarchy under $B_{n}=\partial_{q}^{n}$.

In particular, $\left(T_{N} \cdot \phi_{1}\right)=\left(T_{N} \cdot \phi_{2}\right)=\cdots=\left(T_{N} \cdot \phi_{N}\right)=0$.
Now we can give one theorem reducing the $q$-Wronskian $\tau$ function $\tau_{q}^{(N)}$ in (6.1) of $q$-KP hierarchy to the $q$-cKP hierarchy defined by (5.6).

Theorem 6. $\tau_{q}^{(N)}$ is also a function of the $q$-cKP hierarchy whose Lax operator $L^{l}=\left(L^{l}\right)_{+}+$ $\sum_{i=1}^{M} q_{i} \circ \partial_{q}^{-1} \circ r_{i}$ with some suitable functions $\left\{q_{i}, i=1,2, \ldots, M\right\}$ and $\left\{r_{i}, i=1,2, \ldots, M\right\}$ if and only if

$$
\begin{equation*}
W_{N+M+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, \partial_{q}^{l} \phi_{i_{1}}, \ldots, \partial_{q}^{l} \phi_{i_{M+1}}\right)=0 \tag{6.4}
\end{equation*}
$$

for any choice of $(M+1)$-indices $\left(i_{1}, i_{2}, \ldots, i_{M+1}\right) 1 \leqslant i_{1}<\cdots<i_{M+1} \leq N$, which can be expressed equivalently as

$$
W_{M+1}^{q}\left(\frac{W_{N+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, \partial_{q}^{l} \phi_{i_{1}}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}, \frac{W_{N+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, \partial_{q}^{l} \phi_{i_{2}}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}, \ldots,\right.
$$

$$
\begin{equation*}
\left.\frac{W_{N+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, \partial_{q}^{l} \phi_{i_{M+1}}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}\right)=0 \tag{6.5}
\end{equation*}
$$

for all indices. Here $\left\{\phi_{i}, i=1,2, \ldots, N\right\}$ satisfy (6.2).
Remark 4. This theorem is a $q$-analogue of the classical theorem on cKP hierarchy given by [38].

Proof. The $q$-Wronskian identity proven in Appendix C

$$
\begin{gathered}
W_{M+1}^{q}\left(\frac{W_{N+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, f_{1}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}, \ldots, \frac{W_{N+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, f_{M+1}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}\right) \\
=\frac{W_{N+M+1}^{q}\left(\phi_{1}, \ldots, \phi_{N}, f_{1}, \ldots, f_{M+1}\right)}{W_{N}^{q}\left(\phi_{1}, \ldots, \phi_{N}\right)}
\end{gathered}
$$

implies equivalence between (6.4) and (6.5). Using $T_{N}$ and $T_{N}^{-1}$ in Lemma 5 and the operator identity in (5.5) we have

$$
\begin{equation*}
\left(L^{l}\right)_{-}=\left(T_{N} \circ \partial_{q}^{l} \circ T_{N}^{-1}\right)_{-}=\sum_{i=1}^{N}\left(T_{N}\left(\partial_{q}^{l} \phi_{i}\right)\right) \circ \partial_{q}^{-1} \circ g_{i} \tag{6.6}
\end{equation*}
$$

where $g_{i}$ is given by (6.3) and $T_{N}$ acting on $\left(\partial_{q}^{l} \phi_{i}\right)$ is $T_{N}\left(\partial_{q}^{l} \phi_{i}\right)=\frac{W_{N+1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}, \partial_{q}^{l} \phi_{i}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)}$. So $\tau_{q}^{(N)}$ is automatically a tau function of $N$-component $q$-cKP hierarchy with the form (6.6). Next, we can reduce the $N$-component to the $M$-component $(M<N)$ by a suitable constraint of $\phi_{i}$.

Suppose that the $M$-component $(M<N) q$-cKP hierarchy is obtained by constraint of qKP hierarchy generated by $T_{N}$, i.e., there exist suitable functions $\left\{q_{i}, r_{i}\right\}$ such that

$$
\left(L^{l}\right)_{-}=\sum_{i=1}^{M} q_{i} \circ \partial_{q}^{-1} \circ r_{i}=\sum_{i=1}^{N}\left(T_{N}\left(\partial_{q}^{l} \phi_{i}\right)\right) \circ \partial_{q}^{-1} \circ g_{i}
$$

As we pointed out in previous section, for a Lax operator whose negative part is in the form of $\left(L^{l}\right)_{-}=\sum_{i=1}^{M} q_{i} \circ \partial_{q}^{-1} \circ r_{i}$, there exists an $M$-th order $q$-differential operator A such that $A L^{l}$ is a $q$-differential operator, then we have

$$
0=A L^{l}\left(T_{N}\left(\phi_{i}\right)\right)=A T_{N} \partial_{q}^{l}\left(\phi_{i}\right)=A\left(T_{N}\left(\partial_{q}^{l} \phi_{i}\right)\right)
$$

from $T_{N}\left(\phi_{i}\right)=0$ that implies $T_{N}\left(\partial_{q}^{l} \phi_{i}\right) \in \operatorname{Ker}(A)$. Therefore, at most $M$ of these functions $T_{N}\left(\partial_{q}^{l} \phi_{i}\right)$ can be linearly independent because the Kernel of $A$ has dimension $M$. So (6.5) is deduced.

Conversely, suppose (6.5) is true, we will show that there exists one M-component $q$-ckP $(M<N)$ constrained from (6.6). The equation (6.5) implies that at most $M$ of functions $T_{N}\left(\partial_{q}^{l} \phi_{i}\right)(i=1,2, \ldots, N)$ are linearly independent. Then we can find suitable $M$ functions $\left\{q_{1}, q_{2}, \ldots, q_{M}\right\}$, which are linearly independent, to express functions $T_{N}\left(\partial_{q}^{l} \phi_{i}\right)$ as

$$
T_{N}\left(\partial_{q}^{l} \phi_{i}\right)=\frac{W_{N+1}^{q}\left(\phi_{1}, \phi_{2} \cdots, \phi_{N}, \partial_{q}^{l} \phi_{i}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)}=\sum_{j=1}^{M} c_{i j} q_{j}, \quad i=1, \cdots, N
$$

with some constants $c_{i j}$. Taking this back into (6.6), it becomes

$$
\left(L^{l}\right)_{-}=\sum_{i=1}^{N}\left(\sum_{j=1}^{M} c_{i j} q_{j}\right) \circ \partial_{q}^{-1} \circ g_{i}=\sum_{j=1}^{M} q_{j} \circ \partial_{q}^{-1} \circ\left(\sum_{i=1}^{N} c_{i j} g_{i}\right)=\sum_{j=1}^{M} q_{j} \circ \partial_{q}^{-1} \circ r_{j}
$$

which is an $M$-component $q$-cKP hierarchy as we expected.

## 7 Example reducing $\boldsymbol{q}$-KP to $\boldsymbol{q}$-cKP hierarchy

To illustrate the method in Theorem 6 reducing the $q$-KP to multi-component a $q$-cKP hierarchy, we discuss the $q$-KP generated by $\left.T_{N}\right|_{N=2}$. In order to obtain the concrete solution, we only consider the three variables $\left(t_{1}, t_{2}, t_{3}\right)$ in $\bar{t}$. Furthermore, the $q_{1}, r_{1}$ and $u_{-1}$ are constructed in this section.

According to Theorem 6, the $q$-KP hierarchy generated by $\left.T_{N}\right|_{N=2}$ possesses a tau function

$$
\begin{align*}
\tau_{q}^{(2)}= & W_{2}^{q}\left(\phi_{1}, \phi_{2}\right)=\phi_{1}\left(\partial_{q} \phi_{2}\right)-\phi_{2}\left(\partial_{q} \phi_{1}\right) \\
= & \left(\lambda_{2}-\lambda_{1}\right) e_{q}\left(\lambda_{1} x\right) e_{q}\left(\lambda_{2} x\right) e^{\xi_{1}+\xi_{2}}+\left(\lambda_{3}-\lambda_{1}\right) e_{q}\left(\lambda_{1} x\right) e_{q}\left(\lambda_{3} x\right) e^{\xi_{1}+\xi_{3}} \\
& +\left(\lambda_{3}-\mu\right) e_{q}(\mu x) e_{q}\left(\lambda_{3} x\right) e^{\xi+\xi_{3}}+\left(\lambda_{2}-\mu\right) e_{q}(\mu x) e_{q}\left(\lambda_{2} x\right) e^{\xi+\xi_{2}} \tag{7.1}
\end{align*}
$$

with

$$
\phi_{1}=e_{q}\left(\lambda_{1} x\right) e^{\xi_{1}}+e_{q}(\mu x) e^{\xi}, \quad \phi_{2}=e_{q}\left(\lambda_{2} x\right) e^{\xi_{2}}+e_{q}\left(\lambda_{3} x\right) e^{\xi_{3}}
$$

Here $\xi_{i}=c_{i}+\lambda_{i} t_{1}+\lambda_{i}^{2} t_{2}+\lambda_{i}^{3} t_{3}(i=1,2,3)$, and $\xi=d+\mu t_{1}+\mu^{2} t_{2}+\mu^{3} t_{3}, c_{i}$ and $d$ are arbitrary constants. These functions satisfy the linear equations

$$
\frac{\partial \phi_{i}}{\partial t_{n}}=\partial_{q}^{n} \phi_{i}, \quad n=1,2,3, \quad i=1,2
$$

as a special case of (6.2). From (6.6), the $q$-KP hierarchy generated by $\left.T_{N}\right|_{N=2}$ is in the form of

$$
\begin{align*}
& L^{l}=\left(L^{l}\right)_{+}+\left(T_{2}\left(\partial_{q}^{l} \phi_{1}\right)\right) \circ \partial_{q}^{-1} \circ g_{1}+\left(T_{2}\left(\partial_{q}^{l} \phi_{2}\right)\right) \circ \partial_{q}^{-1} \circ g_{2}  \tag{7.2}\\
& \stackrel{\text { constraint }}{=}=\left(L^{l}\right)_{+}+q_{1} \circ \partial_{q} \circ r_{1} \tag{7.3}
\end{align*}
$$

Here $q_{1}$ and $r_{1}$ are undetermined, which can be expressed by $\phi_{1}$ and $\phi_{2}$ as follows.
According to (6.4), the restriction for $\phi_{1}$ and $\phi_{2}$ to reduce (7.2) to (7.3) is given by

0= & W_{2}^{q}\left(\phi_{1}, \phi_{2}, \partial_{q}^{l} \phi_{1}, \partial_{q}^{l} \phi_{2}\right)=\left(\mu^{l}-\lambda_{1}^{l}\right)\left(\lambda_{2}^{l}-\lambda_{3}^{l}\right) V\left(\lambda_{1}, \lambda_{2}, \lambda_{3}, \mu\right) e^{c_{1}+c_{2}+c_{3}+d} e^{\left(\lambda_{1}+\lambda_{2}+\lambda_{3}+\mu\right) t_{1}} \\

Obviously, we can let $\mu=\lambda_{2}$ and $d=c_{2}$ such that (7.4) holds for $\phi_{1}$ and $\phi_{2}$. Then the $\tau$ function of a single component $q$-cKP defined by (7.3) is

which is deduced from (7.1). That means we indeed reduce the $\tau$ function $\tau_{q}^{(2)}$ in (7.1) of the $q$-KP hierarchy generated by $\left.T_{N}\right|_{N=2}$ to the $\tau$ function $\tau_{q c K P}$ of the one-component $q$-cKP hierarchy. Furthermore, we would like to get the explicit expression of $\left(q_{1}, r_{1}\right)$ of $q$-cKP in (7.3). Using the determinant representation of $\left.T_{N}\right|_{N=2}$ and $\left.T_{N}^{-1}\right|_{N=2}$, we have

under the restriction $\mu=\lambda_{2}$ and $d=c_{2}$. One can find that $f_{1}$ and $f_{2}$ are linearly dependent, and $\left(\lambda_{3}^{l}-\lambda_{2}^{l}\right) f_{1}=\left(\lambda_{1}^{l}-\lambda_{2}^{l}\right) f_{2}$. So (7.2) and (7.3) reduce to

In general, the $l$-constrained one-component $q$-KP hierarchy has the Lax operator $L=\partial_{q}+$ $u_{0}+q_{1} \circ \partial_{q}^{-1} \circ r_{1}$ when $l=1$. On the other hand, its Lax operator can also be expressed as $L=\partial_{q}+u_{0}+u_{-1} \partial_{q}^{-1}+u_{-2} \partial_{q}^{-2}+\cdots$. So all of the dynamical variables $\left\{u_{-i}, i=1,2,3, \ldots\right\}$ of $q$-KP hierarchy are given by

For the present situation, $u_{-1}=u_{-1}\left(t_{1}, t_{2}, t_{3}\right)=q_{1} \theta^{-1}\left(r_{1}\right)$ represents the $q$-deformed solution of the classical KP eqution, which is constructed from the components of $q$-cKP hierarchy, and is of the form

Obviously, they will approach to the classical results on the cKP hierarchy in [38] when $x \rightarrow 0$ and $q \rightarrow 1$. We will fix $\lambda=2, t_{3}=0$ and $c=0$ to plot their figures, then get $q_{1}=q_{1}\left(x, t_{1}, t_{2}, q\right), r_{1}=r_{1}\left(x, t_{1}, t_{2}, q\right)$ and $u_{-1}=u_{-1}\left(x, t_{1}, t_{2}, q\right)$ from (7.5)-(7.7). To save space, we plot the figures for $u_{-1}$ and $q_{1}$ in $\left(t_{1}, t_{2}, t_{3}\right)$ dimension spaces. It can be seen that Fig. 15 of $u_{-1}\left(0.001, t_{1}, t_{2}, 0.999\right)$ and Fig. 20 of $q_{1}\left(0.001, t_{1}, t_{2}, 0.999\right)$ match with the profile of $u_{1}$ and $q$ in [38] with the same parameters. So we define $q$-effects quantity $\triangle u_{-1}=u_{-1}\left(0.5, t_{1}, t_{2}, 0.999\right)-$ $u_{-1}\left(0.5, t_{1}, t_{2}, q\right)=u_{-1}(q=0.999)-u_{-1}(q), \triangle q_{1}=q_{1}\left(0.5, t_{1}, t_{2}, 0.999\right)-q_{1}\left(.5,, t_{1}, t_{2}, q\right)=q_{1}(q=$ $0.999)-q_{1}(q)$, to show their dependence on $q$. Figs. $16-19^{5}$ and Figs. $21-24^{6}$ are plotted for $\triangle u_{-1}$ and $\triangle q_{1}$, respectively, where $q=0.7,0.5,0.3,0.1$. Obviously, they are decreasing to almost zero when $q$ goes from 0.1 to 1 with fixed $x=0.5$. Furthermore, Figs. $25-29^{7}$ show that the dependence of the $q$-effects $\triangle u_{-1}=u_{-1}\left(x, t_{1}, t_{2}, 0.999\right)-u_{-1}\left(x, t_{1}, t_{2}, 0.1\right)=u_{-1}(x, q=$ $0.999)-u_{-1}(x, q=0.1)$ on $x$,where $x=0.2,0.4,0.51,0.53,0.55$ in order. These figures give us again an opportunity to observe the process of $q$-deformation in $q$-soliton solution of $q$-KP equation. They also demonstrate that $q$-deformation keep the profile of the soliton, although there exists deformation in some degree. On the other hand, in fact, $\left(q_{1}, r_{1}\right)$ can be regarded as

a $q$-deformation of dynamical variables $(q, r)$ of AKNS hierarchy, because cKP possessing Lax operator $L=\partial+q \circ \partial^{-1} \circ r$ is equivalent to the AKNS hierarchy.

## 8 Conclusions and discussions

In this paper, we have shown in Theorem 1 that there exist two types of elementary gauge transformation operators for the $q$-KP hierarchy. The changing rules of $q$-KP under the gauge transformation are given in Theorems 2 and 3 . We mention that these two types of elementary gauge transformation operators are introduced first by Tu et al. [15] for $q$-NKdV hierarchy. Considering successive application of gauge transformation, we established the determinant representation of the gauge transformation operator of the $q$-KP hierarchy in Lemma 3 and the corresponding results on the transformed new $q$-KP are given in Theorem 5. For the $q$-KP hierarchy generated by $T_{n+k}$ from the "free" Lax operator $L=\partial_{q}$ (i.e. the Lax operator is $\left.L^{(n+k)}=T_{n+k} \circ \partial_{q} \circ T_{n+k}^{-1}\right)$, Corollary 1 shows that the generalized $q$-Wronskian $I W_{k, n}^{q}$ of functions $\left\{\phi_{i}, \psi_{j}\right\}(i=1,2, \ldots, n ; j=1,2, \ldots, k)$ is a general $\tau$ function of it, and $q$-Wronskian $W_{n}^{q}$ of functions $\phi_{i}(i=1,2, \ldots, n)$ is also a special one. Here $\left\{\phi_{i}\right\}$ and $\left\{\psi_{j}\right\}$ satisfy special linear $q$-partial differential equations (4.5).

The symmetry and symmetry constraint of $q$-KP ( $q$-cKP) hierarchy are discussed in Section 5. On the basis of the representation of $T_{N}$ in Lemma 5 , the $q$-KP hierarchy whose Lax operator $L^{l}=T_{N} \circ \partial_{q}^{l} \circ T_{N}^{-1}$ is generated from the "free" Lax operator $L=\partial_{q}$. The explicit form of its negative part $L_{-}^{l}$ is given in (6.6), which is called $l$-constraint of the $q$-KP hierarchy. Further we found necessary and sufficient conditions that are given in Theorem 6 , reducing a $q$-Wronskian solution in (6.1) of the $q$-KP hierarchy to solutions of the multi-component $q$-cKP hierarchy. One example is given in Section 7 to illustrate the method, i.e., the $q$-KP generated by $\left.T_{N}\right|_{N=2}$

is reduced to one-component $q$-cKP hierarchy. By taking finite variables $\left(t_{1}, t_{2}, t_{3}\right)$ in $\bar{t}$, the component $q_{1}$ and $r_{1}$ are written out. Our results can be reduced to the classical results in [38].

As we pointed out in Section 2, $u_{-1}$ is the $q$-analogue of the solution of classical KP equation if we only consider three variables $\left(t_{1}, t_{2}, t_{3}\right)$ in $\bar{t}$. Therefore, the solution $u_{-1}$ is called $q$-soliton of the $q$-KP equation, although we do not write out the $q-\mathrm{KP}$ equation on $u_{-1}$. One can find that the equations of dynamical variables $\left\{u_{0}, u_{-i}\right\}$ in $q$-KP hierarchy are coupled with each other and can not get one $q$-partial differential equation associated only with one dynamical variable, like classical KP equation has one dynamical variable $u_{-1}$. The reason is that the $q$-Leibnitz rule contains $q$-differential operation and $\theta$ operation, however, the Leibnitz rule of the standard calculus only contains one differential operation. We get a single $q$-soliton $u_{-1}$ by means of the simplest $\tau$ function $\tau_{q}=W_{1}^{q}\left(\phi_{1}\right)=\phi_{1}$ in Section 4. Meanwhile, the multi- $q$-soliton $u_{-1}$ is obtained from one-component $q$-cKP hierarchy in Section 7. Figures of $q$-effect $\triangle u_{-1}$ show that $q$-soliton $u_{-1}$ indeed goes to classical soliton of KP equation when $x \rightarrow 0$ and $q \rightarrow 1$ and $q$-deformation does not destroy the rough profile of the $q$-soliton. In other worlds, the figure of $q$-soliton is similar to the classical soliton of KP equation. We also show the trends of the $q$-effect $\Delta u_{-1}$ depends on $x$ and $q ; x$ plays a role of the amplifier of $q$-effects. In conclusion, the figures of $q$-effects $\triangle u_{-1}$ let us know the process of $q$-deformation in integrable systems for the first time. Of course, it is a long way to explore the physical meaning of $q$ from the soliton theory.

In comparison with the research of classical soliton theory [40], in particular, the KP hierarchy [36, 37], the cKP [25, 31] hierarchy and the AKNS [40] hierarchy, there exist at least several topics needed to be discussed in order to research the integrability property of nonlinear $q$-partial differential equations. For instance, the Hamiltonian structure the $q$-cKP hierarchy and its $q$-W-algebra; the gauge transformation of the $q$-cKP hierarchy; the $q$-Hirota equation as-

sociated with the bilinear identity of the $q$-KP hierarchy; the symmetry analysis of $q$-differential equation and $q$-partial differential equations; the interaction of $q$-solitons; the $q$-AKNS hierarchy and its properties. Since the KP hierarchy has $B$-type and $C$-type sub-hierarchies, what are $q$-analogues of them? In particular, we showed in the previous sections that convergence of $e_{q}(x)$ affects the $q$-soliton, so the analytic property of $e_{q}(x)$ is a basis for research the interaction of $q$-solitons. We will try to investigate these questions in the future.

& -\frac{(5)_{q}(6)_{q}(7)_{q}}{q^{5+6+7}(2)_{q}(3)_{q}} \theta^{-8}\left(\partial_{q}^{3} f\right) \partial_{q}^{-8}+\frac{(5)_{q}(6)_{q}(7)_{q}(8)_{q}}{q^{5+6+7+8}(2)_{q}(3)_{q}(4)_{q}} \theta^{-9}\left(\partial_{q}^{4} f\right) \partial_{q}^{-9}+\cdots \\
& +\frac{(-1)^{k}(k+1)_{q}(k+2)_{q}(k+3)_{q}(k+4)_{q}}{q^{5+6+7+\cdots+(k+3)+(k+4)}(2)_{q}(3)_{q}(4)_{q}} \theta^{-5-k}\left(\partial_{q}^{k} f\right) \partial_{q}^{-5-k}+\cdots

The first few of $B_{n}$ are in the form of

& v_{-1}=\left(\partial_{q} u_{-1}\right)+\theta\left(u_{-2}\right)+u_{0} u_{-1}+u_{-1} \theta^{-1}\left(u_{0}\right)+u_{-2},
\end{aligned}
$$

and

\begin{aligned}
& \tilde{s}_{2}=\theta\left(v_{1}\right)+u_{0}, \quad \tilde{s}_{1}=\left(\partial_{q} v_{1}\right)+\theta\left(v_{0}\right)+u_{0} v_{1}+u_{-1}, \\
& \tilde{s}_{0}=\left(\partial_{q} v_{0}\right)+\theta\left(v_{-1}\right)+u_{0} v_{0}+u_{-1} \theta^{-1}\left(v_{1}\right)+u_{-2} .
\end{aligned}

Note that $v_{-1}$ comes from $L^{2}=B_{2}+v_{-1} \partial_{q}^{-1}+v_{-2} \partial_{q}^{-2}+\cdots$.

## C Proof of the $\boldsymbol{q}$-Wronskian identity

1) The first $N$ steps. Consider the gauge transformation generated by the order of $\left\{\phi_{i}, i=\right.$ $1,2, \ldots, N\}$

T_{D}^{(1)}\left(\phi_{1}\right) \longrightarrow T_{D}^{(2)}\left(\phi_{2}^{(1)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(i)}\left(\phi_{i}^{(i-1)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(N)}\left(\phi_{N}^{(N-1)}\right)
$$

Assume there are $l$ functions $\left\{\phi_{N+j}^{(N)}, j=1,2, \ldots, l\right\}$ expressed by

$$
\phi_{N+j}^{(N)}=\left(T_{N} \cdot \phi_{N+j}\right)=\frac{W_{N+1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}, \phi_{N+j}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)},
$$

which are generated by $T_{N}$ from $\left\{\phi_{j}\right\}$. Here $\phi_{i}(i=1,2, \ldots, N+l)$ are arbitrary functions such that the gauge transformations can be constructed.
2) The last $l-1$ steps. Let $y_{j}=\phi_{N+j}^{(N)}(j=1,2, \ldots, l)$. Using $y_{j}(j=1,2, \ldots, l-1)$ as the generating functions in order of $T_{D}$, we can construct $(l-1)$ steps of gauge transformation operators as

T_{D}^{(1)}\left(y_{1}\right) \longrightarrow T_{D}^{(2)}\left(y_{2}^{(1)}\right) \longrightarrow T_{D}^{(3)}\left(y_{3}^{(2)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(l-1)}\left(y_{l-1}^{(l-2)}\right) .
$$

According to the determinant of $\left.T_{N}\right|_{N=j}(j=1,2, \ldots, l-1)$, we have

$$
y_{i}^{(j)}=\left(T_{j} \cdot y_{i}\right) \begin{cases}0 & \text { if } j \geq i \\ \frac{W_{j+1}^{q}\left(y_{1}, y_{2}, \ldots, y_{j}, y_{i}\right)}{W_{j}^{q}\left(y_{1}, y_{2}, \ldots, y_{j}\right)} & \text { if } j<i\end{cases}
$$

then

$$
\begin{gather*}
y_{1} \cdot y_{2}^{(1)} \cdot y_{3}^{(2)} \cdots y_{l-1}^{(l-2)} y_{l}^{(l-1)}=y_{1} \frac{W_{2}^{q}\left(y_{1}, y_{2}\right)}{W_{1}^{q}\left(y_{1}\right)} \frac{W_{3}^{q}\left(y_{1}, y_{2}, y_{3}\right)}{W_{2}^{q}\left(y_{1}, y_{2}\right)} \ldots \\
\frac{W_{l-1}^{q}\left(y_{1}, y_{2}, \ldots, y_{l-2}, y_{l-1}\right)}{W_{l-2}^{q}\left(y_{1}, y_{2}, \ldots, y_{l-2}\right)} \frac{W_{l}^{q}\left(y_{1}, y_{2}, \ldots, y_{l-2}, y_{l-1}, y_{l}\right)}{W_{l-1}^{q}\left(y_{1}, y_{2}, \ldots, y_{l-2}, y_{l-1}\right)} \\
=W_{l}^{q}\left(y_{1}, y_{2}, \ldots, y_{l}\right)=W_{l}^{q}\left(\phi_{N+1}^{(N)}, \phi_{N+2}^{(N)}, \ldots, \phi_{N+l}^{(N)}\right) . \tag{C.1}
\end{gather*}

3) Combine two chains of gauge transformations above. In fact, we can combine two chains into one,

& T_{D}^{(1)}\left(\phi_{1}\right) \longrightarrow T_{D}^{(2)}\left(\phi_{2}^{(1)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(i)}\left(\phi_{i}^{(i-1)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(N)}\left(\phi_{N}^{(N-1)}\right) \\
& T_{D}^{(N+1)}\left(\phi_{N+1}^{(N)}\right) \longrightarrow T_{D}^{(N+2)}\left(\phi_{N+2}^{(N+1)}\right) \longrightarrow T_{D}^{(N+3)}\left(\phi_{N+3}^{(N+2)}\right) \longrightarrow \cdots \longrightarrow T_{D}^{(N+l-1)}\left(\phi_{N+l-1}^{(N+l-2)}\right) .
\end{aligned}
$$

The determinant representation of $\left.T_{N}\right|_{N+j}$ implies $(1<i, j<l)$ :

\phi_{N+i}^{(N+j)}=\left(T_{N+j} \cdot \phi_{N+i}\right)= \begin{cases}0 & \text { if } j \geq i \\ \frac{W_{N+j+1}^{q}\left(\phi_{1}, \phi_{2} \cdots, \phi_{N}, \phi_{N+1}, \cdots, \phi_{N+j}, \phi_{N+i}\right)}{W_{N+j}^{q}\left(\phi_{1}, \phi_{2} \cdots, \phi_{N}, \phi_{N+1}, \cdots, \phi_{N+j}\right)} & \text { if } j<i\end{cases}
$$

So

$$
\begin{align*}
\phi_{N+1}^{(N)} & \cdot \phi_{N+2}^{(N+1)} \cdot \phi_{N+3}^{(N+2)} \cdots \phi_{N+l-1}^{(N+l-2)} \phi_{N+l}^{(N+l-1)}=\frac{W_{N+1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}, \phi_{N+1}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)} \times \\
& \times \frac{W_{N+2}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+1}, \phi_{N+2}\right)}{W_{N+1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+1}\right)} \frac{W_{N+3}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+2}, \phi_{N+3}\right)}{W_{N+2}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+2}\right)} \cdots \\
& \times \frac{W_{N+l-1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+l-2}, \phi_{N+l-1}\right)}{W_{N+l-2}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+l-2}\right)} \frac{W_{N+l}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+l-1}, \phi_{N+l}\right)}{W_{N+l-1}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+l-1}\right)} \cdots \\
& =\frac{W_{N+l}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N+l-1}, \phi_{N+l}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)} \tag{C.2}
\end{align*}

The left hand side of (C.1) equals the left hand side of (C.2), which is followed by

\frac{W_{N+l}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}, \phi_{N+1}, \ldots, \phi_{N+l-1}, \phi_{N+l}\right)}{W_{N}^{q}\left(\phi_{1}, \phi_{2}, \ldots, \phi_{N}\right)}=W_{l}^{q}\left(\phi_{N+1}^{(N)}, \phi_{N+2}^{(N)}, \ldots, \phi_{N+l}^{(N)}\right)
$$

It should be noted that the proof above is independent of the form of $\phi_{k}$, so we can replace $\phi_{N+j}$ with $\left(\partial_{q}^{l} \phi_{N+j}\right)$. This completes the proof of the $q$-Wronskian identity.
