# Existence of foliations on 4{ manifolds

Alexandru Scorpan

**Abstract** We present existence results for certain singular 2{dimensional foliations on 4{manifolds. The singularities can be chosen to be simple, for example the same as those that appear in Lefschetz pencils. There is a wealth of such creatures on most 4{manifolds, and they are rather flexible: in many cases, one can prescribe surfaces to be transverse or be leaves of these foliations.

The purpose of this paper is to o er objects, hoping for a future theory to be developed on them. For example, foliations that are taut might o er genus bounds for embedded surfaces (Kronheimer's conjecture).

#### 1 Introduction

Foliations play a very important role in the study of  $3\{\text{manifolds}, \text{ but almost none so far in the study of } 4\{\text{manifolds}. \text{ There are hints, though, that they should play an important role here as well. For example, for <math>M^4 = N^3 \quad \mathbb{S}^1$ , Kronheimer obtained genus bounds for embedded surfaces from certain taut foliations [11], which are sharper than the ones coming from Seiberg{Witten basic classes. He conjectured that such bounds might hold in general.

#### 1.1 Summary

(In this paper, all foliations will be  $2\{$ dimensional and oriented, all manifolds will be  $4\{$ dimensional, closed and oriented; unless otherwise speci ed, of course.)

For a foliation F to exist on a manifold M, the tangent bundle must split  $T_M = T_F$   $N_F$ . Since in general that does not happen, one must allow for singularities of F. An important example is [6]:




Figure 1: A Lefschetz pencil

**Example 1.1** *S.K. Donaldson 1999* Let  $\mathcal{J}$  be an almost-complex structure on  $\mathcal{M}$  that admits a compatible symplectic structure (*i.e.*  $\mathcal{J}$  admits a closed 2{form  $\mathcal{I}$  such that  $\mathcal{I}(x;\mathcal{J}x) > 0$  and  $\mathcal{I}(\mathcal{J}x;\mathcal{J}y) = \mathcal{I}(x;y)$ ). Then  $\mathcal{J}$  can be deformed to an almost-complex structure  $\mathcal{J}^{\emptyset}$  such that  $\mathcal{M}$  admits a Lefschetz pencil with  $\mathcal{J}^{\emptyset}$ {holomorphic bers.

A Lefschetz pencil is a singular bration M !  $\mathbb{CP}^1$  with singularities modeled locally by

$$(Z_1; Z_2) \neq Z_1 = Z_2$$
 or  $(Z_1; Z_2) \neq Z_1 = Z_2$ 

for suitable local complex coordinates (compatible with the orientation of M). Note that all bers pass through all singularities of type  $Z_1 = Z_2$ , see Figure 1. The existence of a Lefschetz pencil is equivalent to the existence of a symplectic structure. See [9, ch. 8] for a survey.

A main result of this paper (Theorem 2.1) is that, under mild homological conditions on M, any almost-complex structure J on M can be deformed to a  $J^{\ell}$  that admits a *singular foliation* with  $J^{\ell}$  {holomorphic leaves, and with singularities of the same type as those appearing in a Lefschetz pencil. In fact, the singularities can be chosen to be all of  $z_1 = z_2$  {type (\pencil" singularities), and thus could be eliminated by blow-ups. Other singularities can also be chosen (or even just a single complicated singularity), see Section 4.6.

By allowing singularities with reversed orientations, this existence result can be generalized to  $spin^C$ -structures (Theorem 4.15). ( $Spin^C$ -structures are more general than almost-complex structures and always exist on any  $4\{manifold.\}$ 

Also, under certain natural conditions, given embedded surfaces can be arranged to be transversal to the foliations (Theorem 2.7), or even to be leaves of the foliations (Theorem 2.8).

The main tools used in proving our results are: Thurston's  $h\{\text{principle for foliations with codimension} 2$  (see 4.1 below), which takes care of integrating plane- elds and reduces the existence problem to bundle theory; and the Dold{ Whitney Theorem characterizing bundles by their characteristic classes (see 4.6 below). In a nutshell, we build a bundle with the same characteristic classes as  $T_M$ , we conclude it is  $T_M$ , we let Thurston integrate to a foliation.

This paper presents existence results for singular  $2\{$ dimensional foliations on  $4\{$ manifolds. We o er a wealth of objects to be used in a future theory, and try to stimulate interest in this area.

The paper is organized as follows: Section 2 contains the statements of most results of this paper, Section 3 o ers a quick survey of the context in foliation theory, Section 4 presents the proofs of our results, while Section 5 contains left-overs.

## 1.2 Why bother?

One hint that foliations on 4{manifolds are worth studying (especially *taut* foliations, see Section 3.2 for a discussion) are Kronheimer's results (see Theorem 3.8 and Conjecture 3.9 below). Taut foliations might o er *minimal genus bounds* for embedded surfaces, see Section 3.3.

In a slightly larger context, the relationship (if any) between foliations on 4{ manifolds and *Seiberg{Witten theory* is worth elucidating.

Another question worth asking is: For what foliations is the induced almost-complex structure  $\ne$  (*i.e.* close to symplectic). One such problem asks for which foliations does the induced almost-complex structure have *Gromov compactness* (*i.e.* whether the space of  $\mathcal{J}$ {holomorphic curves of a xed genus and homology class is compact; see Question 3.3).

In general, one can hope that foliations will help better visualize, manipulate and understand *almost-complex structures*, maybe in a manner similar to the one in which open-book decompositions help understand contact structures on 3{manifolds (see also Corollary 3.2).

#### 2 Statements

(In this paper, Poincare duality will be used blindly, submanifolds and the homology classes they represent will frequently be denoted with the same symbol, and top (co)homology classes will be paired with fundamental cycles without comment. For example, (M) – could be written more elegantly as (M) – (I)[M], while  $c_1(L)$  = is  $c_1(L) = PD([])$ .)

First of all, notice that any (non-singular) foliation F on M induces almost-complex structures: Pick a Riemannian metric g, embed the normal bundle  $N_F$  in  $T_M$ , then de ne an almost-complex structure  $J_F$  to be the rotation by =2 (respecting orientations) in both  $T_F$  and  $N_F$ . It has the property that the leaves of F are  $J_F$  {holomorphic. (In general, we will call an almost-complex structure J compatible with a foliation F if J makes the leaves of F be J {holomorphic.) The rst Chern class  $c_1(J_F)$  is well-de ned independent of the choices made. We have:

$$c_1(J_F) = e(T_F) + e(N_F)$$
$$(M) = e(T_F) - e(N_F)$$

If the foliation F has singularities, then the second equality above fails, and the defect  $(M) - e(T_F) e(N_F)$  measures the number of singularities (or, for more general singularities, their complexity, see Theorem 2.5).

#### 2.1 Main existence results

Call a class  $c \ 2 \ H^2(M; \mathbb{Z})$  a complex class of the 4{manifold M if

$$c \quad w_2(M) \pmod{2}$$
 and  $p_1(M) = c^2 - 2 \pmod{M}$ 

An element  $c \ 2 \ H^2(M;\mathbb{Z})$  is a complex class if and only if there is an almost-complex structure J on M such that  $c_1(T_M;J)=c$ . One direction is elementary: If J is such a structure, then  $(T_M;J)$  is a complex-plane bundle, and thus has  $c_1(T_M) = w_2(T_M) \pmod{2}$  and  $p_1(T_M) = c_1(T_M) - 2c_2(T_M)$ . The converse was proved in [19, 10] (and will appear here re-proved as part of Corollary 4.9).

**Theorem 2.1** (Existence Theorem) Let  $c \ 2 \ H^2(M; \mathbb{Z})$  be a complex class, and let c = + be any splitting such that (M) - 0. Choose any combination of n = (M) - singularities modeled on the levels of the complex functions  $(z_1; z_2) \ 7! \ z_1 = z_2 \ \text{or} \ (z_1; z_2) \ 7! \ z_1 z_2$ . Then there is a singular foliation F with  $e(T_F) = e(N_F) = 0$ , and with P singularities as prescribed.

**Remark 2.2** Due to the singularities, the bundles  $T_F$  and  $N_F$  are only dened on M n fsingularities g. Their Euler classes a priori belong to  $H^2(M n f)$  fsingularities g,  $\mathbb{Z}$ ), but can be pulled-back to  $H^2(M; \mathbb{Z})$ , since the isolated singularities can be chosen to a ect only the 4-skeleton of M, and thus to not influence  $H^2$ .

**Remark 2.3** Unlike a Lefschetz pencil, in general *not all* leaves of the foliation pass through the  $z_1 = z_2$  {singularities. See Example 3.1 for creating a leaf that touches no singularity.

#### 2.2 Restrictions

Finding a splitting c = + with (M) - 0 is possible for most 4 { manifolds that admit almost-complex structures. For example, if

$$(M)$$
 0

(*e.g.* for all *simply-connected M*'s), then one can choose either one of to be 0, and conclude that such foliations exist. Or:

**Lemma 2.4** If  $b_2^+(\mathcal{M}) > 0$ , then there are in nitely many splittings c = + with  $(\mathcal{M}) - 0$  (and thus in nitely many homotopy types of foliations).

**Proof** If  $b_2^+(\mathcal{M}) > 0$ , there is a class with > 0. Choose = c - k and  $= k (k 2 \mathbb{Z})$ . Then  $(\mathcal{M}) - = (\mathcal{M}) - kc + k^2$ , and for k big enough it will be positive.

The main restriction to the existence of such foliations remains, of course, the existence of a complex class. But Theorem 2.1 can be generalized for the case when c is merely an *integral lift* of  $w_2(M)$ , see Theorem 4.15. In that case, singularities are also modeled using local complex coordinates, but are allowed to be compatible either with the orientation of M or with the *opposite orientation*.

This is similar to the generalization of Lefschetz pencils to achiral Lefschetz pencils, see [9, x8.4] and Section 4.7. As it happens, the only known obstruction to the existence of an achiral Lefschetz pencil ([9, 8.4.12{13]) is the only obstruction to the existence of such an \achiral" singular foliation (see Section 4.7 and Proposition 4.18).

#### 2.3 Singularities

The singularities of F are exactly the singularities that appear in a Lefschetz pencil. They can be chosen in either combination of types as long as their number is n = (M) – . For example, there are always foliations with only  $z_1 = z_2$  (singularities, that can thus be eliminated by blowing-up. In fact, other choices of singularities are possible.

Namely, for any isolated singularity p of a foliation that is compatible with an almost-complex structure we will de ne its *Hopf degree* deg *p* a Hopf invariant of the tangent plane eld above a small  $3\{\text{sphere around } p;$ see Section 4.6). Then:

**Theorem 2.5** Let  $c \in \mathcal{Z} \cap \mathcal{H}^2(M; \mathbb{Z})$  be a complex class, and let c = +any splitting such that (M) – 0. Then, for any choice of (positive) singularities  $fp_1, \dots, p_k g$  so that

$$\deg p_i = (M) -$$

there is a singular foliation F with  $e(T_F) = e(N_F) = e(N_F)$ , and with the chosen singularities.

In analogy to the Poincare{Hopf theorem on indexes of vector elds, a converse to the above is true:

**Proposition 2.6** For any singular foliation *F* on *M* with isolated singularities  $fp_1; \dots; p_k g$  compatible with a local almost-complex structure, we have  $(M) = \deg p_i + e(T_F) \quad e(N_F)$ 

$$(M) = \bigcup_{i=1}^{P} \deg p_i + e(T_F) \quad e(N_F)$$

#### Prescribing leaves and closed transversals 2.4

Let F be a foliation. If S is a closed transversal of F, then we must have

$$e(T_F)$$
  $S = e(T_F j_S) = e(N_S) = S$   $S$   $e(N_F)$   $S = e(N_F j_S) = e(T_S) = (S)$ 

These conditions are, in fact, su cient:

**Theorem 2.7** (Closed transversal) Let S be a closed connected surface. Let c be a complex class with a splitting c = + such that (M) - 0. If

$$(S) = S$$
  $S = S$ 

then there is a singular foliation F with  $e(T_F) = 0$ ,  $e(N_F) = 0$ , and having S as a closed transversal.

If, on the other hand, S is a closed leaf of F, then we have

$$e(T_F)$$
  $S = e(T_F j_S) = e(T_S) = (S)$   
 $e(N_F)$   $S = e(N_F j_S) = e(N_S) = S$   $S$ 

Conversely:

**Theorem 2.8** (Closed leaf) Let S be a closed connected surface with S S 0. Let c be a complex class with a splitting c = + such that (M) - S S. If

$$(S) = S$$
  $S = S$ 

then there is a singular foliation F with  $e(T_F) = 0$ ,  $e(N_F) = 0$ , and having S as a closed leaf. (The number of singularities along S is S S.)

(Surfaces with S S < 0 could be made leaves of achiral singular foliations, using singularities with reversed orientations, see 4.25.)

An immediate consequence of the above is:

**Corollary 2.9** (Trivial tori) A homologically-trivial torus can always be made a leaf or a transversal of a foliation.

Such flexibility is a strong suggestion that more rigidity is needed in order to actually catch any of the topology of M with the aid of foliations. Requiring foliations to be taut seems a natural suggestion. (Compare with Example 3.1.)

The conditions (S) = S and S S = S from 2.8 add to (S) + S S = C S. The conditions (S) = S and (S) = S from 2.7 also add to (S) + S S = C S. For good choices of and , that is su cient:

**Corollary 2.10** (Adjunct surfaces) Let c be a complex class, and let S be a closed connected surface such that

$$(S) + S S = c S$$

If (M) - (S) = 0, then there is a singular foliation  $F_1$  with  $e(T_{F_1}) = S$  that has S as a closed transversal. If further (M) - (S) = S = 0, then there is also a singular foliation  $F_2$  with  $e(N_{F_2}) = S$  that has S as a leaf (with S S singularities on it).

Proof For F_1, pick = S and = C - S. For F_2, pick = C - S and = S. (In both cases = (S), and so (M) - (M) -
```

As a consequence of (the proof of) 2.10, we can also re-prove the following [2]:

**Proposition 2.11** (C. Bohr 2000) Let S be an embedded closed connected surface and c a complex class. Then there is an almost-complex structure J with  $c_1(J) = c$  such that S is J{holomorphic if and only if S = c S.

**Proof** The positivity condition (M) - (S) 0 is only needed for integrating the singularities of the foliations, and thus it can be ignored here. We have a (singular) plane eld  $T_F$  that is transverse to S, and a (singular) plane eld  $N_F$  that can be arranged to be tangent to S. These plane elds induce an almost-complex structure  $J_F$  that leaves  $T_S$  invariant.

#### 3 Context

#### 3.1 Foliations and Gromov compactness

First, an example that shows the flexibility of foliations:

**Corollary 3.2** Any almost-complex structure is homotopic to one for which Gromov compactness fails.




Figure 2: Creating a torus leaf (3D movie)

*\Gromov compactness"* here means the compactness of the space of all  $\mathcal{J}\{$  holomorphic curves (curve = real surface). In other words, any sequence of holomorphic curves  $f_n$ : (  $:j_n$ ) ! ( $M:\mathcal{J}$ ) has a subsequence converging to a limit f: ( :j) ! ( $M:\mathcal{J}$ ) that is holomorphic (and may have nodal singularities; the limit domain—is obtained by collapsing circles in—). Gromov compactness always holds for almost-complex structures that admit symplectic structures. (In fact, the essential property needed is that the areas of  $f_n$ ( ) be bounded; for a thorough discussion, see [1].)

**Proof** By Theorem 2.1, an almost-complex structure can be deformed till there is a singular foliation F with all leaves holomorphic. As in Example 3.1 above, create a torus leaf. Actually, by \freezing" the movie at t = 0 (expanding the




Figure 3: Create torus leaf (2D movie)

frame at t=0 to all  $t \ 2 \ [-";"]$ ), create a lot of tori. Now pick a second curve, orthogonal to these tori, and apply that example again. What appears in the end is a torus that explodes to make room for a new Reeb component. Thinking in terms of an almost-complex structure  $\mathcal J$  induced by the nal foliation, we have a sequence of  $\mathcal J$ {holomorphic tori that has no decent limit.

**Question 3.3** (R. Kirby 2002) Let F be a foliation on M, and J an almost-complex structure making the leaves J{holomorphic. What conditions imposed on F insure that Gromov compactness holds for J?

In the extreme, if F is a Lefschetz pencil, then Gromov compactness holds (the manifold is symplectic). Compare also with Proposition 3.11.

The flexibility from our examples, at least, is done away with if we require the foliations to be *taut* (since Reeb components kill tautness).

#### 3.2 Taut foliations

A foliation F on a Riemannian manifold (M;g) is called *minimal* if all its leaves are minimal surfaces in (M;g) (*i.e.* they locally minimize area; for any compact piece K of a leaf, any small perturbation of K rel @K will have bigger area; that is equivalent to each leaf having zero mean curvature).

A foliation F on M is called *taut* if there is a Riemannian metric g such that F is minimal in (M;g). (See [3, ch. 10] for a general discussion.)

**Remark 3.4** In the special case of a codimension-1 foliation, tautness is equivalent to the existence of a 1{manifold transverse to F and crossing all the leaves. A similar condition is too strong for higher codimensions.

Tautness can be expressed in terms of 2{forms [14]:

**Theorem 3.5** (H. Rummler 1979) Let F be a foliation on M. Then F is taut if and only if there is a 2 {form such that  $j_{Leaf} > 0$  and d  $j_{Leaf} = 0$ .

We write  $\ \ j_{Leaf} > 0$  and  $d \ j_{Leaf} = 0$ " as shorthand for  $\ \ (\ _1;\ _2) > 0$  and  $d \ (\ _1;\ _2;z) = 0$ , for any orienting pair  $\ _1;\ _2 \ 2\ T_F$  and any  $z \ 2\ T_M$ ".

The strong link between 2{forms and minimality of foliations is also suggested (via almost-complex structures) by the following formula:

**Lemma 3.6** Let g(x;y) = hx; yi be a Riemannian metric on  $M^4$  and r its Levi-Civita connection. Let J be any  $g\{$ orthogonal almost-complex structure, and let f(x;y) = hJx; f(x;

$$d! (x; Jx; z) = [x; Jx]; Jz - r_x x + r_{Jx} Jx; z$$

The term [x;Jx] measures the integrability of the  $J\{\text{holomorphic plane} \text{ eld } \mathbb{R}hx;Jxi, \text{ while the normal component of the term } r_xx+r_{Jx}Jx \text{ is the mean curvature of the plane} \text{ eld } \mathbb{R}hx;Jxi, \text{ and thus measures its } g\{\text{minimality.} \text{ (Lemma 3.6 will be proved at the end of the paper, in Section 5.)}$ 

#### 3.3 Minimal genus of embedded surfaces

Given any class  $a\ 2\ H_2(M;\mathbb{Z})$ , there are always embedded surfaces in M that represent it. An open problem is to determine how simple such surfaces can be, or, in other words, what is the minimal genus that a surface representing a can have. (Remember that (S) = 2 - 2g(S), so minimum genus is maximum Euler characteristic.)

Notice that, if S is a  $\mathcal{J}$ {holomorphic surface for some almost-complex structure  $\mathcal{J}$ , then

$$(S) + S$$
  $S = c_1(J)$   $S$ 

(simply because  $c_1(J)$   $S = c_1(T_M j_S) = c_1(T_S) + c_1(N_S) = (S) + S S$ ). This equality is known as the \adjunction formula" for S.

In general, the main and most powerful tool for obtaining genus bounds comes from Seiberg{Witten theory [12, 13]:

$$(S) + S S " S$$

In particular, if  $\mathcal J$  is an almost-complex structure admitting a symplectic structure, then

$$(S) + S S C_1(J) S$$

Nonetheless, the bounds o ered by Seiberg{Witten basic classes are not always sharp. For example, in the case of manifolds  $M = N^3$   $\mathbb{S}^1$ , P. Kronheimer has proved in [11] that foliations give *better* bounds:

**Theorem 3.8** (P. Kronheimer 1999) Consider  $M = N^3 \mathbb{S}^1$ , with N a closed irreducible 3 {manifold. Let  $\overline{F}$  be a taut foliation in N, with Euler class " =  $e(T_{\overline{F}})$ . Let " be the image of " in  $H^2(N \mathbb{S}^1)$ . Then, for any embedded surface S in M, without sphere components, we have

$$(S) + S S " S$$

In general, "is *not* a Seiberg{Witten basic class. (Nonetheless, the proof of Theorem 3.8 does use Seiberg{Witten theory: the taut foliation  $\overline{F}$  is perturbed to a tight contact structure, which is then symplectically lled in a suitable way, and a version of the Seiberg{Witten invariants is used: "is a \monopole class".)

Taut foliations  $\overline{F}$  on 3{manifolds are well-understood, and are strongly related to minimal genus surfaces there: If  $N^3$  is a closed irreducible 3{manifold, then an embedded surface S has minimal genus if and only if it is the leaf of a taut foliation of N [18, 8]. (A similar statement on 4{manifolds is not known.)

A taut foliation  $\overline{F}$  on  $\mathbb{N}^3$  induces an obvious product foliation  $F=\overline{F}$   $\mathbb{S}^1$  on  $M=\mathbb{N}$   $\mathbb{S}^1$  (with leaves Leaf fptg). Then F is also taut (pick a product metric), "=  $e(T_F)$  is the pull-back of "=  $e(T_{\overline{F}})$ , and the almost-complex structure that F determines has  $c_1(J_F)=$  "=  $e(T_F)$ . One can then try to generalize Theorem 3.8 as

**Conjecture 3.9** (P. Kronheimer 1999) Let F be a taut foliation on  $M^4$ , and  $J_F$  be an almost-complex structure induced by F. Then, for any embedded surface S without sphere components, we have

$$(S) + S S C_1(J_F) S$$

A few extra requirements are needed, *e.g.* to exclude manifolds like  $S \mathbb{S}^2$ . Kronheimer also proposes that the foliations be allowed singularities.

**Remark 3.10** The situation in Theorem 3.8 has another peculiarity: F admits transverse foliations. Indeed, since  $\overline{F}$  has codimension 1, any nowhere-zero vector- eld in  $\mathbb{N}^3$  normal to  $\overline{F}$  integrates to a 1{dimensional foliation of  $\mathbb{N}$  that is transverse to  $\overline{F}$ . By multiplying its leaves by  $\mathbb{S}^1$ , this 1{dimensional foliation induces a 2{dimensional foliation in  $\mathbb{N}$  that is transverse to F.

One could thus think of strengthening the hypothesis of Conjecture 3.9 by requiring F not only to be taut, but also to admit a transverse foliation. One might push things even further and ask that the second foliation be taut as well. But then one almost runs into:

**Proposition 3.11** (Two taut makes one symplectic) Let F and G be transverse foliations on  $M^4$ . If there is a metric g that makes both F and G be minimal and orthogonal, then M must admit a symplectic structure. Therefore, for any embedded surface S we have

$$(S) + S S c_1(J_F) S$$

(This is an immediate consequence of Lemma 3.6.)

**Remark 3.12** *No taut, no symplectic.* At the other extreme, if M admits a *non-taut* foliation F, then *no* almost-complex structure compatible with F admits symplectic structures (or, more directly, M admits no symplectic structures making the leaves of F symplectic submanifolds).

#### 4 Proofs

#### 4.1 Thurston's theorem

The tool that we use for obtaining foliations is the h{principle discovered by W. Thurston [17] for such objects:

**Theorem 4.1** (W. Thurston 1974) Let T be a 2 {plane eld on a manifold M of dimension at least 4. Let K be a compact subset of M such that T is completely integrable in a neighborhood of K (K can be empty). Then T is homotopic rel K to a completely integrable plane eld.

This theorem is also true on 3{manifolds (see [16]), but *not* in a relative version. The theorem above is proved by rst lifting the plane eld to a Haefliger structure, and then deforming the latter to become a foliation using the main theorem of [17]. The latter result has an alternative proof in [7].

**Remark 4.2** A problem with using Thurston's theorem is that, when following its proof to build foliations, one only gets *non-taut* foliations. Indeed, certain holes in the foliation being built have to be lled-in with Reeb components.

Thurston's theorem reduces the problem of building foliations to the problem of nding singular plane- elds on M, or, more exactly, singular splittings  $T_M = T$  N. \Singular" because the di erence between  $T_M$  and the sum T N will be a surgery modi cation that we present next:

#### 4.2 Surgery modi cations

If E ! M is an oriented 4{plane bundle and B is a 4{ball around a point X, then we can cut out  $Ej_B$  and glue it back in using an automorphism of  $Ej_{@B}$ . Choose a chart in M around B and use some quaternion coordinates  $\mathbb{R}^4$   $\mathbb{H}$ , so that @B  $\mathbb{S}^3$ , the sphere of units in  $\mathbb{H}$ . Since the ber of E is 4{dimensional and  $Ej_B$  is trivial, we can choose some quaternion bundle-coordinates on E, so that  $Ej_B$   $\mathbb{H}$  B. Then  $Ej_{@B}$   $\mathbb{H}$   $\mathbb{S}^3$ .

Quaternions can be used to represent SO(4) acting on  $\mathbb{R}^4$  as  $\mathbb{S}^3$   $\mathbb{S}^3$  1 acting on  $\mathbb{H}$  through  $[q_+:q_-]h=q_+hq_-^{-1}$ . For any  $m:n\ 2\ \mathbb{Z}$ , we de ne a map  $\mathbb{S}^3$  ! SO(4) by

$$m:n(q)h = q^m h q^n$$

where  $q \ 2 \ \mathbb{S}^3$  and  $h \ 2 \ \mathbb{H}$   $\mathbb{R}^4$ . Notice that the map m;n determines an element of  ${}_3SO(4)$ . In fact, we have the isomorphism  $\mathbb{Z}$   $\mathbb{Z}$   ${}_3SO(4)$  given by  $(m;n) \ ! \ [m;n]$  (see [15]). Homotopically we have [m;n] + [p;q] = m;n p;q = [m+p;n+q].

The (m;n) {surgery modi cation of E is then de ned as follows: Pick a point x in M and a 4{ball B around it. Cut  $Ej_B$  out from E and glue it back using the automorphism

$$Ej_{@B}$$
 ——!  $Ej_{@B}$   
 $(x;h)$  7!  $x;_{m:n}(x)h$ 

Denote the resulting bundle by  $E_{m;n}$ .

**Remark 4.3** It is equivalent to perform (m;n) {surgery at one point x, or to perform (1;0) {surgeries at m points  $x_1, \ldots, x_m$  and (0;1) {surgeries at n points  $x_1, \ldots, x_n$  (or any other combination that adds up to (m;n) in  $\mathbb{Z}$   $\mathbb{Z}$ ).

To understand the result of such a modi cation, we study its characteristic classes:

#### 4.3 Characteristic classes

An oriented  $k\{\text{bundle over }\mathbb{S}^n \text{ is uniquely determined by the homotopy class of an equatorial gluing map }\mathbb{S}^{n-1} \text{! } SO(k), \text{ and thus } \text{Vect}_k\mathbb{S}^n = \binom{n-1}{n-1}SO(k).$ 

In particular, all oriented 4 {bundles on  $\mathbb{S}^4$  correspond one-to-one with  $_3SO(4)$ . Therefore all of them can be obtained by (m;n) {surgery modi cations. Denote by  $\mathbb{R}^4_{m;n}$  the bundle on  $\mathbb{S}^4$  obtained from the trivial bundle  $\mathbb{R}^4 = \mathbb{R}^4$   $\mathbb{S}^4$  through a (m;n) {modi cation.

Note that addition of gluing maps in  $_3SO(4)$  survives as addition of characteristic classes of bundles in H ( $\mathbb{S}^4;\mathbb{Z}$ ). In particular, for any characteristic class  $\mathfrak{c}$ , we have

$$\mathfrak{c}(\underline{\mathbb{R}}_{m;n}^4) = m\mathfrak{c}(\underline{\mathbb{R}}_{1;0}^4) + n\mathfrak{c}(\underline{\mathbb{R}}_{0;1}^4)$$

It is known that (1:1) (surgery on  $\mathbb{R}^4$   $\mathbb{S}^4$  will yield the tangent bundle  $\mathcal{T}_{\mathbb{S}^4}$  of  $\mathbb{S}^4$  (see [15]). Since  $e(\mathcal{T}_{\mathbb{S}^4}) = (\mathbb{S}^4) = 2$ , we deduce that

$$e(\underline{\mathbb{R}}_{1;0}^4) + e(\underline{\mathbb{R}}_{0;1}^4) = 2$$

On the other hand,  $\mathcal{T}_{\mathbb{S}^4}$   $\underline{\mathbb{R}} = \underline{\mathbb{R}}^5$ , so  $p_1(\mathcal{T}_{\mathbb{S}^4}) = p_1(\mathcal{T}_{\mathbb{S}^4} \quad \underline{\mathbb{R}}) = 0$ , and so  $p_1(\underline{\mathbb{R}}^4_{1:0}) + p_1(\underline{\mathbb{R}}^4_{0:1}) = 0$ 

The bundle  $\underline{\mathbb{R}}_{1;-1}^4$  is obtained by surgery with  $_{1;-1}(q)h = qhq^{-1}$ . The latter preserves the real line  $\mathbb{R}$   $\mathbb{H}$  of the ber, and therefore the bundle  $\underline{\mathbb{R}}_{1;-1}^4$  splits o a trivial real-line bundle. Therefore  $e(\underline{\mathbb{R}}_{1;-1}^4) = 0$ . That means

$$e(\underline{\mathbb{R}}_{1:0}^4) - e(\underline{\mathbb{R}}_{0:1}^4) = 0$$

Combining with the above yields

$$e(\underline{\mathbb{R}}_{1:0}^4) = 1 \qquad \qquad e(\underline{\mathbb{R}}_{0:1}^4) = 1$$

**Remark 4.4** Complex structures on quaternions The complex plane  $\mathbb{C}^2$  can be identified with the quaternions  $\mathbb{H}$  in two ways:

- (1)  $(z_1; z_2)$   $z_1 + z_2j$  (and then complex scalars are multiplying in  $\mathbb{H}$  on the left, and the natural orientations of  $\mathbb{C}^2$  and  $\mathbb{H}$  are preserved; quaternion multiplication on the right is  $\mathbb{C}\{\text{linear}, \text{ and } \mathbb{S}^3 \text{ acting on the right identies with } SU(2)\}$
- (2)  $(z_1; z_2)$   $z_1 + j z_2$  (with complex scalars multiplying on the right, but with the orientations *reversed*; quaternions multiplying on the left act  $\mathbb{C}\{\text{linearly}, \mathbb{S}^3 \text{ on the left is } SU(2)\}$ .

(We will make use of both of these identications: (1) will be used here, while (2) in x4.7.)

We identify  $\mathbb{C}^2$  with  $\mathbb{H}$  using  $(z_1;z_2)$   $z_1+z_2j$ . Since the bundle  $\underline{\mathbb{R}}^4_{0;1}$  is built using the map  $_{0;1}(q)h=hq$ , and the latter preserves multiplication by complex scalars on the left, we deduce that  $\underline{\mathbb{R}}^4_{0;1}$  can be seen as a complex-plane bundle (the same is true for all  $\underline{\mathbb{R}}^4_{0;n}$ ). Thus  $\underline{\mathbb{R}}^4_{0;1}$  has well-de ned Chern classes. Since  $c_2(\underline{\mathbb{R}}^4_{0;1})=e(\underline{\mathbb{R}}^4_{0;1})$  and  $c_1(\underline{\mathbb{R}}^4_{0;1})$   $2H^2(\mathbb{S}^4)$ , we see that

$$c_1(\underline{\mathbb{R}}_{0;1}^4) = 0 \qquad c_2(\underline{\mathbb{R}}_{0;1}^4) = 1$$

Since for complex bundles we have  $p_1 = c_1^2 - 2c_2$ , we deduce that

$$\rho_1(\underline{\mathbb{R}}_{0:1}^4) = -2$$

and therefore, combining with the above,

$$p_1(\underline{\mathbb{R}}_{1,0}^4)=2$$

Therefore:

$$e(\underline{\mathbb{R}}_{m;n}^4) = m + n$$
  $p_1(\underline{\mathbb{R}}_{m;n}^4) = 2m - 2n$ 

In conclusion, for any oriented 4{plane bundle  $E ! \mathbb{S}^4$ , we have

$$e(E_{m:n}) = e(E) + m + n$$
  $p_1(E_{m:n}) = p_1(E) + 2m - 2n$ 

This change of characteristic classes for bundles over  $\mathbb{S}^4$  is also what happens over a general 4{manifold M. This can be seen, for example, using the obstruction-theoretic de nition of characteristic classes (de ned locally cell-bycell): away from the modi cation, it does not matter if we are left with a small neighborhood of the south pole, or with M n Ball. (Or, one could argue that M n Ball; BSO(4) is nite, while  $p_1$  are e are rational, etc.)

**Lemma 4.5** For any  $4\{\text{plane bundle } E \mid M, \text{ a } (m; n) \} \{\text{modi cation of } E \}$  will change its characteristic classes as follows:

$$e(E_{m;n}) = e(E) + m + n$$
  $p_1(E_{m;n}) = p_1(E) + 2m - 2n$ 

## 4.4 Obtaining the tangent bundle

Assume  $c \ 2 \ H^2(M; \mathbb{Z})$  is an integral lift of the Stiefel{Whitney class  $w_2(M) \ 2 \ H^2(M; \mathbb{Z}_2)$ . For any splitting c = +, build the complex-line bundles L and L such that  $c_1(L) =$  and  $c_1(L) =$ . Let E = L L. Then  $c_1(E) = c$  and  $c_2(E) =$ . Thus, as a real 4{plane bundle, E has  $w_2(E) = w_2(M)$ .

If we can modify E to an  $E^{\emptyset}$  so that we also have  $e(E^{\emptyset}) = (M)$  and  $p_1(E^{\emptyset}) = p_1(M)$ , then  $E^{\emptyset} = T_M$ . That is due the fact that characteristic classes determine bundles up to isomorphism [4]:

**Theorem 4.6** (A. Dold & H. Whitney 1959) Let  $E_1$ ! M and  $E_2$ ! M be two oriented 4{plane bundles over an oriented 4{manifold M. If  $w_2(E_1) = w_2(E_2)$ ,  $e(E_1) = e(E_2)$ , and  $p_1(E_1) = p_1(E_2)$ , then  $E_1 = E_2$ .

Now, since

$$e(E_{m;n}) = e(E) + m + n = + m + n$$

$$p_1(E_{m;n}) = p_1(E) + 2m - 2n = c_1(E)^2 - 2c_2(E) + 2m - 2n$$

$$= c^2 - 2 + 2m - 2n$$

we obtain that  $e(E_{m;n}) = e(T_M)$  and  $p_1(E_{m;n}) = p_1(T_M)$  if and only if

$$m = \frac{1}{4} p_1(M) + 2 (M) - c^2$$
  

$$n = \frac{1}{4} -p_1(M) + 2 (M) + c^2 - 4$$

**Remark 4.7** These m and n are always integers. The quick argument is: on the one hand, the formula for m above gives exactly the dimension of the Seiberg{Witten moduli space associated to the spin<sup>C</sup>-structure given by c (it is the index of a di erential operator), and thus is known to be integral; on the other hand, n = -m + (M) - ...

In conclusion:

**Proposition 4.8** (Splitting the Tangent Bundle) Let  $: 2 H^2(M; \mathbb{Z})$  be such that c = + is an integral lift of  $w_2(M) \ 2 H^2(M; \mathbb{Z}_2)$ . Let L : L be complex-line bundles with  $c_1(L) =$  and  $c_1(L) =$ . Then

$$(L L)_{m:n} T_M$$

where

$$m = \frac{1}{4} p_1(M) + 2 (M) - c^2$$
  

$$n = \frac{1}{4} -p_1(M) + 2 (M) + c^2 - 4$$

In the case = 0, this is a statement that we learned (together with its proof) from R. Kirby's lectures at U. C. Berkeley. (The advantage of using a more complicated sum L L versus the simpler  $L_c$   $\mathbb{R}^2$  will become apparent when we move toward foliations.)

In the special case when c is a complex class (*i.e.* when c, besides being an integral lift of  $w_2(M)$ , also satis es  $p_1(M) = c^2 - 2$  (M)), we have

$$m = 0$$
  $n = (M) - ab$ 

Since m=0, that means, in particular, that the surgery modi cation is made with  $_{0;n}(q)h=hq^n$ , which is  $\mathbb{C}\{\text{linear}, \text{ and thus will preserve the complex structure of } L$ . Therefore  $T_M$  inherits a complex-structure. We have thus built an almost-complex structure J on M with  $c_1(T_M;J)=c$ .

**Corollary 4.9** Let ;  $2H^2(M;\mathbb{Z})$  be such that + is a complex class. Let L:L be complex-line bundles with  $c_1(L)=$  and  $c_1(L)=$ . Then M admits an almost-complex structure J with  $c_1(J)=+$ , and, for n=(M)-, we have

$$(T_M;J)$$
  $(L L)_{0:n}$ 

as complex bundles.

**Remark 4.10** If (M) - 0, then the complex bundle  $(T_M; J)$  can be obtained from L L by surgery modi cations at n = (M) - points using 0.1.

Through the isomorphism  $(L \quad L)_{m;n} \quad T_M$ , the line-bundles L and L survive as plane- elds  $\mathcal{E}$  and  $\mathcal{E}$  in  $T_M$  de ned o the modi cation points. If we nd a way to prolong  $\mathcal{E}$  across its singularities by a singular foliation,

then we could use Thurston's Theorem 4.1 (in its relative version) to integrate the whole  $\pounds$  to a foliation F (while keeping it xed at the singularities). This foliation would then, o the singularities, have  $T_F$  L and  $N_F$  L, and thus have well-de ned Euler classes  $e(T_F) = \text{and } e(N_F) = \text{in } H^2(M; \mathbb{Z})$  (since the isolated singular points cannot influence  $H^2$ , see Remark 2.2).

Finding nice singularities is what we do next:

## 4.5 Singularities

We keep identifying  $\mathbb{H}$   $\mathbb{C}^2$  using  $z_1 + z_2 j$   $(z_1; z_2)$ . In particular  $\mathbb{R}h1$ ;  $ii = \mathbb{C}$  in  $\mathbb{H}$  is  $\mathbb{C}$  0 in  $\mathbb{C}^2$ .

Consider the action of  $_{0;1}$  on  $\mathbb{S}^3$   $\mathbb{H}$ . Since  $_{0;1}(q)$  1=q and  $_{0;1}$  is  $\mathbb{C}\{\text{linear},$  we deduce that  $_{0;1}(q)$   $\mathbb{C}=\mathbb{C}q$ . In other words, the trivial subbundle  $\mathbb{S}^3$   $\mathbb{C}$  is taken by  $_{0;1}$  to the subbundle fqg  $\mathbb{C}q$  whose ber over a point q of  $\mathbb{S}^3$  is the complex plane spanned by q.

Assume now that c = + is a complex class and that n = (M) - 0. Then we can build  $T_M$  from L L as above, by modifying at n points using 0.1.

Choose coordinates on a small  $4\{\text{ball }B \text{ around a modi cation point }X \text{ so that the bers of }L \text{ on }\mathbb{S}^3=\mathscr{C}B \text{ are }\mathbb{C}\mathbb{H}.$  Then  $_{0;1}$  will glue the ber of L over  $q \geq \mathbb{S}^3$  to the plane  $\mathbb{C}q$ . The latter can be identified though with the tangent planes to the submanifolds  $\mathbb{C}q$  of the unit ball in  $\mathbb{C}^2$  bounded by  $\mathbb{S}^3$ . Or, in other words,  $q \neq 1$   $_{0;1}(q)$  L is tangent to the levels of the complex function  $(z_1, z_2) \neq 1$   $z_1 = z_2$  (from  $\mathbb{C}^2 n = 0$  to  $\mathbb{C}\mathbb{P}^1$ ).




Figure 4: Filling with a pencil singularity.

These levels can be used to  $\mbox{ll-in}$  the singularity of the foliation  $\mbox{\it F}$  obtained by deforming  $\mbox{\it L}$  (see Figure 4). We call such a ( $\mbox{lled-in}$ ) singularity a *pencil singularity*.

Since we are dealing with bundles, though, what essentially matters when lling a singularity is only the *homotopy class* of its boundary plane eld  $q \not= 0.1 (q)$  L, seen as a map  $\mathbb{S}^3$ !  $\mathbb{CP}^1$ . That is completely determined by the homotopy class of any spanning vector eld (for example  $q \not= 0.1 (q)$ ), seen as a map  $\mathbb{S}^3$ !  $\mathbb{S}^3$ .

**Remark 4.11** The two homotopy classes are related by the Hopf map  $\mathfrak{h}:\mathbb{S}^3$  !  $\mathbb{CP}^1=\mathbb{S}^2$ , which establishes the isomorphism  ${}_3\mathbb{S}^3$   ${}_3\mathbb{S}^2$ . Technically, a map  $u:\mathbb{S}^3$ !  $\mathbb{S}^3$  has a *degree*, while a map  $v:\mathbb{S}^3$ !  $\mathbb{CP}^1$  has a *Hopf invariant*. When  $v=\mathbb{C}$  u (that is:  $v=\mathfrak{h}u$ ), the two coincide, and we will call them \degree" in both instances.

Consider the levels of the complex function  $(z_1; z_2)$   $\not\vdash z_1 z_2$ . The tangent space to the level through  $(z_1; z_2)$  is the complex span of  $(z_1; -z_2)$ . The latter, restricted to a map  $\mathbb{S}^3$  !  $\mathbb{S}^3$ , has degree 1. The plane eld  $\mathcal{E}_a j_{\mathbb{S}^3}$  also has degree 1 (since it is spanned by  $q \not\vdash q$ ). Therefore  $\mathcal{E}_a$  can be homotoped to become tangent to the levels of the function  $(z_1; z_2) \not\vdash z_1 z_2$ .




Figure 5: A quadratic singularity (fake image).

Thus the levels of  $z_1z_2$  o er another possible way of lling-in the singularities of F (see Figure 5). (Notice that these levels are isomorphic to the levels of  $(z_1; z_2)$  7!  $z_1^2 + z_2^2$ .) We will call such a (lled-in) singularity a *quadratic* singularity.

**Proof of Existence Theorem 2.1** Let c be a complex class of M, and c = + a splitting such that n = (M) - is non-negative. Then, by 4.9, we have  $(L \ L)_{0:n} \ T_M$ , for complex-line bundles L and L with  $c_1(L) =$  and  $c_1(L) =$ . We choose to perform the surgery by n modi cations by 0:1 at n points  $p_1; \ldots; p_n$ . The bundle L survives in  $T_M$  as a singular plane- eld  $\mathbb{E}$ . Choose any assortment of n pencil or quadratic singularities, and place them at the points  $p_1; \ldots; p_n$ . Arrange  $\mathbb{E}$  so that it is tangent to the leaves of the singularities. Use Thurston's Theorem 4.1 (p. 1238) to homotop  $\mathbb{E}$  (away from the singularities) so that it becomes integrable. The resulting singular foliation F is what we needed to build.

Of course, many other singularities can be chosen, see Section 4.6 below. We

singled out  $z_1$ = $z_2$  and  $z_1z_2$  now because they are exactly the singularities that appear in a Lefschetz pencil. Unlike a Lefschetz pencil, though, *not* all leaves must pass through a pencil singularity. (For example, use the method of Example 3.1 to create a torus leaf that does not touch any singularity).

The choice being given, pencil singularities are the most manageable: A pencil singularity can be removed by blowing M up: the blow-up simply separates the leaves of F that were meeting there, and thus the foliation survives with one less singularity. That is not the case for a quadratic singularity: blowing-up creates one more singularity for the foliation (since the exceptional sphere must now become a leaf), and instead of one there are now two quadratic singularities. On the other hand, a quadratic singularity creates at most two singular leaves, while a pencil singularity creates uncountably many. Also, in rare occasions, if one of the leaves that passes through a quadratic singularity is a sphere with self-intersection -1, one might attempt to blow it down while preserving the rest of the foliation. (Notice that the existence of a sphere leaf with non-zero self-intersections is not excluded by Reeb stability if the leaf passes through a singularity.)

#### 4.6 Other singularities

Other singularities may be used, as stated in Theorem 2.5. What matters is their *Hopf degree*, de ned as follows:

If F is a foliation with an isolated singularity at p, then choose a small 4{ball B around p. If the plane- eld  $T_F j_{@B}$  is left invariant by some local almost-complex structure on B that is compatible with the orientation of M, then we call p a singularity of *positive type*.

For a singularity of positive type, we de ne its *Hopf degree* as the degree (Hopf invariant) of the plane eld  $T_F j_{@B}$  seen as maps  $@B ! \mathbb{CP}^1$  (i.e.  $\mathbb{S}^3 ! \mathbb{S}^2$ ). (Technically, if one wants the Hopf degree to depend only on the singularity and not on the chosen neighborhood B, one should de ne the Hopf degree as a *limit* as B shrinks to p.)

The most obvious candidates for singularities of positive type are, of course, singularities de ned by levels of complex functions. But since a complex function will always preserve orientations, *any* singularity coming from a complex function will have *non-negative* Hopf degree. Thus, while we can easily nd singularities for any positive Hopf degree (that can be used to ll-in the singularities created by (0;n) {modi cations when n=0}, singularities of negative Hopf degree seem harder to ll-in the author does not know how to ll-in the singularity created by ll-1, which is why many statements have a positivity condition like ll-10.

**Example 4.12** *Cusp singularity.* The singularity de ned by the levels F(f) of the function

$$f(z_1; z_2) = z_1^3 - z_2^2$$

It has  $Dfj_Z=3z_1^2; -2z_2$ , and thus  $T_{F(f)}j_Z=\ker Dfj_Z=\mathbb{C}(2z_2;3z_1^2)$ . A generic equation  $(2z_2;3z_1^2)=(w_1^0;w_2^0)$  has two solutions, orientations are preserved, and thus

$$\deg F(f) = 2$$

**Example 4.13** *Normal crossing.* The singularity de ned by

$$g(z_1;z_2)=z_1^p z_2^q$$

has 
$$Dgj_Z = \rho z_1^{\rho-1} z_2^q$$
;  $qz_1^\rho z_2^{q-1}$ , so  $T_{F(g)}j_Z = \mathbb{C}(qz_1; -\rho z_2)$ , and thus  $\deg F(g) = 1$ 

**Example 4.14** The singularity de ned by

$$k(z_1; z_2) = z_1^{p+1} + z_2^{q+1}$$

has  $Dkj_Z=(p+1)Z_1^p$ ;  $(q+1)Z_2^q$  , so  $T_{F(k)}j_Z=\mathbb{C}(q+1)Z_2^q$ ;  $(p+1)Z_1^p$  , and thus

$$\deg F(k) = pq$$

This last example shows that all positive degrees are realized by concrete singularities. According to one's taste, one can choose to use, say, a cusp singularity instead of two pencil singularities. What matters is that the Hopf degrees of the

singularities add up to n=(M)-, as is stated in Theorem 2.5. One could even use just a single singularity of Hopf degree n=(M)-, for example  $(z_1;z_2)$   $\mathcal{F}!$   $z_1^{n+1}+z_2^2$ .

In particular, this concludes the proofs of Theorem 2.5 and Proposition 2.6.

## 4.7 Beyond almost-complex

Lefschetz pencils generalize to *achiral Lefschetz pencils*. Those are Lefschetz pencils with singularities still modeled on  $(z_1; z_2)$   $\neq !$   $z_1 = z_2$  and  $(z_1; z_2)$   $\neq !$   $z_1 = z_2$  and  $(z_1; z_2)$   $\neq !$   $z_1 = z_2$ , but this time one can use local complex coordinates that are either compatible with the orientation of M, or compatible with the *opposite orientation* (see [9,  $\times 8.4$ ]).

In the same spirit, the Existence Theorem 2.1 can be easily generalized to a theorem that holds for more general 4{manifolds and splittings (for cases when m from Proposition 4.8 is non-zero and (1/0){modi cations are needed), and guarantees the existence of what we could call *achiral singular foliations*.

The surgical modi cation  $_{1,0}(q)h = qh$  can be thought of as  $\mathbb{C}\{$  linear for the complex structure given on  $\mathbb{H}$  by multiplication with complex scalars on the *right* (see Remark 4.4(2)). The ensuing identication  $\mathbb{C}^2 = \mathbb{H}$ ,  $(z_1; z_2)$   $z_1 + jz_2$ , *reverses* orientations. Nonetheless, the singularities appearing from surgical modications with  $_{1,0}$  can be lled-in with the complex planes for *this* complex structure, yielding a good local model (an \anti-complex" or \negative" pencil singularity). Note that any two of these complex planes will now intersect *negatively*. Such a singularity can be eliminated by an anti-complex blow-up.

More generally, of course, we can call an isolated singularity p of F of negative type if the plane- eld  $T_F$  on a small 3{sphere around p is preserved by a local almost-complex structure compatible with the *opposite* orientation of M. Then one can de ne the *Hopf degree* just as for singularities of positive type. The formulas from the examples above have the same degrees if we choose local complex coordinates that induce the *opposite* orientation.

In conclusion, we have:

**Theorem 4.15** (Achiral Existence Theorem) Let  $c \ 2 \ H^2(M; \mathbb{Z})$  be any integral lift of  $w_2(M)$ , and let c = + be any splitting. Let

$$m = \frac{1}{4} p_1(M) + 2 (M) - c^2$$
  

$$n = \frac{1}{4} -p_1(M) + 2 (M) + c^2 - 4$$

If m=0 and n=0, then there is an achiral singular foliation F with  $e(T_F)=$ ,  $e(N_F)=$ , and m+n singularities. The singularities can be chosen to be modeled on the levels of the complex functions  $(z_1;z_2)$  7!  $z_1=z_2$  or  $(z_1;z_2)$  7!  $z_1z_2$ , with n of them for complex-coordinates respecting the orientation, and m of them for complex-coordinates reversing the orientation of M.

More generally, for any choice of singularities  $fp_1; ...; p_k g$  of positive type and any choice of singularities  $fq_1; ...; q_l g$  of negative type so that  $\deg p_i = n$  and  $\deg q_i = m$ , there is an achiral singular foliation F having exactly these singularities, and with  $e(T_F) = \operatorname{and} e(N_F) = .$ 

**Remark 4.16** An integral lift c of  $w_2(M)$  is essentially a spin<sup>C</sup>-structure. It always exists (modulo 2{torsion in  $H^2$ ). One can think of spin<sup>C</sup>-structures as generalizations of almost-complex structures.

**Example 4.17** The 4{sphere  $\mathbb{S}^4$  admits an achiral Lefschetz pencil with 2{ spheres meeting in a positive and a negative pencil singularity. (Fibrate  $\mathbb{CP}^2$  by all the projective lines passing through a point, then do an anti-complex blow-down on any transverse line.)

The condition m=0 was the only *known* obstruction to the existence of achiral Lefschetz pencils (compare Lemma 8.4.12 in [9]). Since achiral Lefschetz pencils are special cases of singular foliations, the theorem above adds the condition n=0. Also, since these are the *only* conditions needed for the existence of a foliation, and foliations should be expected to be much more flexible than Lefschetz pencils, this result suggests that more obstructions to the existence of achiral Lefschetz pencils probably exist and need to be uncovered.

The following obstruction to the existence of achiral singular foliations is Theorem 8.4.13 from [9] (substituting foliations for Lefschetz pencils).

**Proposition 4.18** Let M be a 4 {manifold with positive-de nite intersection form. Assume that M admits an achiral singular foliation F with only singular points of negative type  $fq_1, \ldots, q_k g$ . Let  $m = \deg q_i$ . Then

$$1 - b_1(M) + b_2(M)$$
 m

**Proof** The class  $c = e(T_F) + e(N_F)$  in  $H^2(M; \mathbb{Z})$  has  $c = w_2(M) \pmod{2}$ . Thus it is a characteristic element for the intersection form:  $c \pmod{2}$ . By Donaldson's celebrated result [5], a smooth  $4\{\text{manifold with positive-de nite intersection form } b_2(M)$  (1). Let  $f_jg$  be

any basis for the intersection form written as above. Then  $c = \begin{bmatrix} a_j & j + b_2 \\ b_2 & M \end{bmatrix}$  torsion part, where and all  $a_j$  must be *odd* integers. Then  $c^2 = \begin{bmatrix} a_j & j + b_2 \\ b_2 & M \end{bmatrix}$  analogue of Proposition 2.6, m must satisfy  $m = \frac{1}{4} p_1(M) + 2 (M) - c^2$ . Since  $p_1(M) = 3 (M)$ , we deduce that (M) + (M) = 2m, which is the same as  $1 - b_1(M) + b_2(M) = m$ .

**Example 4.19** The manifold  $\#^k \mathbb{S}^3$   $\mathbb{S}^1$  admits no achiral singular foliations if k > 1. Indeed,  $1 - b_1 + b_2 = 1 - k < 0$ . (For k = 1, we have a bration by tori, products with  $\mathbb{S}^1$  of the circle- bers of the Hopf bration of  $\mathbb{S}^3$ .)

#### 4.8 Closed leaves and transversals

The strategy for proving Theorems 2.8 and 2.7 (on prescribing closed leaves and closed transversals) is the same as for the Existence Theorem 2.1: Before using Thurston's Theorem 4.1 to homotop the plane- eld  $\stackrel{p}{\mathbb{E}}$  to a foliation, we arrange it so that it is already integrable in a certain region where either it is transversal to a certain surface or tangent to a certain surface. By keeping that region xed, we end up with a foliation that is either transversal to the surface or has it as a leaf.

A few small steps are necessary:

$$T_M j_{N_S} = {}_S T_S \qquad {}_S N_S$$




Figure 6: Building a complex-line bundle with  $c_1 = S$

**4.21** For any surface , one can built a complex-line bundle L with Chern class  $c_1(L)$  = as follows: Take N and pull-it back over itself using . The resulting bundle N!N is trivial o , since the section s:N!N , s(v) = (v;v) (think NNN), is non-zero o and hence trivializes (see Figure 6). Therefore one can extend the bundle N from over NNN0 to over the whole N1, gluing it to some trivial bundle over N2, N3. The result is a complex-line bundle (= oriented real 2{plane bundle}) L with a section

(an extension of s) that is zero only over  $t_{M}$ , so  $c_{1}(L) = t_{M}$ . Notice that, while  $t_{M}$  can be considered as a subbundle of  $t_{M}$ , in general the same is no longer true of  $t_{M}$ .

**4.22** Consider now an embedded *connected* surface *S* and a homology 2{class such that

$$(S) = S$$




Figure 7: Identifying bers, for 4.22 and 4.23

Represent by an embedded surface A transverse to S, and build a complex-line bundle  $L_A$  with  $c_1(L_A) = A$  as above, in 4.21: extend  ${}_AN_A$ !  $N_A$  over the whole M. Near A, the bundle  $L_A$  is a subbundle of  $T_M$  and has a section s(v) = (v, v) as above. On the other hand, build the bundle  ${}_ST_S$ !  $N_S$  as a subbundle of  $T_M$  near S. Arrange that over the intersection  $N_S \setminus N_A$  the bers of  ${}_ST_S$  and  ${}_AN_A$  (i.e.  $L_A$ ) coincide (see Figure 7, left). (Do that such that  ${}_ST_S$  is still complementary to  ${}_SN_S$  in  $T_Mj_{N_S}$ .) Then the section S of  ${}_AN_A$  is also a section of  ${}_ST_S$  de ned near A. Viewed there, it looks like a vector eld tangent to S, de ned only near A and with zeros along A. But S0 and so the zeros of S1 along S2 are the only obstructions to a non-zero extension of S3 to the whole S5. We end up with a subbundle S5 along S6. If we glue it to a trivial bundle over the rest of S7, the result will be S7. The difference is that now S8 a subbundle of S9 and is complementary there to S1. With a bit of care, we can actually get

$$L_A j_{N_S} = {}_S T_S$$

**4.23** Consider an embedded *connected* surface S and a class such that

$$S S = S$$

Then represent by an embedded surface B transverse to S and build  $L_B$  as before, in 4.21. Build also  $_SN_S$ !  $N_S$ , and arrange so that the bers of  $_BN_B$  coincide to the bers of  $_SN_S$  over  $N_S \setminus N_B$  (see Figure 7, right). (Do that so that  $_SN_S$  stays complementary to  $_ST_S$  in  $T_Mj_{N_S}$ .) The section S of  $_BN_B$  is now also a section of  $_SN_S$  de ned near B. It looks like a normal vector eld to S, de ned near B and with zeros on B. But S S = B S, and thus S can be extended to a global section of  $_SN_S$  with zeros only along B. We end up with  $_SN_S$  [  $_BN_B$ , subbundle of  $T_M$  over  $N_S$  [  $N_B$ , that is trivialized o S. It can be extended trivially to the whole S0, yielding S1. But now S2 a subbundle of S3, and is complementary there to S5. With a bit of care, we even get

$$L_B j_{N_S} = {}_S N_S$$

**4.24** Combine 4.22 and 4.23: Let S be a *connected* surface, and let S and be such that

$$(S) = S$$
 and  $S S = S$ 

Represent and by transverse surfaces A and B, then simultaneously rebuild the bundles  $L_A$  and  $L_B$  in such a manner that they are complementary subbundles of  $T_M j_{\text{near } S}$ . Namely,

$$L_A j_{N_S} = {}_S T_S$$
 and  $L_B j_{N_S} = {}_S N_S$ 

Notice that  ${}_SN_S$  is arranged to be tangent to the bers of  $N_S$ . Also, if S has trivial normal bundle, then  ${}_ST_S$  can be arranged to be tangent to parallel copies of S (and to S itself) in  $N_S$ .

Notice that, if  $(L_A \ L_B)_{m:n} \ T_M$ , then the resulting singular plane elds  $\mathcal{E}_A$  and  $\mathcal{E}_B$  can be kept xed near S, so that  $\mathcal{E}_A j_{N_S} = {}_S T_S$  and  $\mathcal{E}_B j_{N_S} = {}_S N_S$ .

In general, though, they *cannot* be kept xed near A or B. Indeed, there they must pass through an isomorphism of the type N T  $\mathcal{N}$   $\mathbb{R}^2$  (since T  $\mathbb{R} = \mathbb{R}^3$ ), where  $\mathcal{N}$  is an isomorphic copy of N, but a copy that is *not* normal to when embedded in  $T_M$ . This moved copy  $\mathcal{N}$  becomes part of  $\mathcal{E}$ , while  $\mathbb{R}^2$  becomes part of the complementary bundle.

Finally, we are ready to assemble the above steps into the proofs of 2.7 and 2.8:

#### **Proof of Transversal Theorem 2.7** The statement we need to prove is:

Let S be a closed connected surface. Let c be a complex class with a splitting c = + such that (M) - 0. If (S) = S and S S = S then there is a singular foliation F with  $e(T_F) = +$ ,  $e(N_F) = +$ , and having S as a closed transversal.

Build the line bundles L and L following the recipe from 4.24. Do the surgical modi cations on L L far from S. The resulting singular plane elds  $\mathcal{E}$  and  $\mathcal{E}$  now have  $\mathcal{E}$   $j_{N_S} = {}_S N_S$ , and thus  $\mathcal{E}$  can be arranged to be tangent to the bers of  $N_S$  in M (in other words,  $\mathcal{E}$  is integrable near S). Keeping the plane eld  $\mathcal{E}$  xed near the lled-in singularities and near S, we end up, after applying Thurston's Theorem 4.1, with a singular foliation F having the bers of  $N_S$  as pieces of leaves. Thus S is everywhere transverse to the F.  $\square$ 

#### **Proof of Leaf Theorem 2.8** The statement we need to prove is:

Let S be a closed connected surface with S S O. Let c be a complex class with a splitting c = + such that (M) - S S. If (S) = S and S S = S then there is a singular foliation F with  $e(T_F) = +$   $e(N_F) = +$  and having S as a closed leaf. (The number of singularities along S is S S.)

**A.** Assume rst that the normal bundle  $N_S$  of S is trivial. Build the line bundles L and L following the recipe from 4.24. Do the surgical modi cations on L L far from S. The resulting singular plane elds  $\mathcal{E}$  and  $\mathcal{E}$  now have  $\mathcal{E}$   $j_{N_S} = {}_S T_S$ , and, since  $N_S$  is trivial,  $\mathcal{E}$  can be arranged to be tangent to parallel copies of S. Keeping the plane eld  $\mathcal{E}$  xed near the lled-in singularities and near S, we end up, after applying Thurston's Theorem 4.1, with a singular foliation with S (and its parallel copies) as leaves.




Figure 8: Foliating around S when  $N_S$  is non-trivial

**B.** In general, if  $N_S$  is not trivial, then we will place pencil singularities along S, as suggested in Figure 8. Having foliated a neighborhood of S, we can essentially apply the same recipe as above.

Notice that the condition (M) – S S is there merely to ensure that we have enough singularities available. We leave the remaining details of the proof of the Leaf Theorem 2.8 to the elusive interested reader.

If one starts with a surface with S S < 0, then one could try to use negative singularities to foliate a neighborhood. Thus, one needs achiral foliations:

**Proposition 4.25** Let S be a closed connected surface with S S < 0. Let c; ; m; n be as in 4.15. If m -S S and n 0, then there is an achiral singular foliation having S as a leaf.

# 5 Appendix

**Proof of Lemma 3.6** We prove that, if g is a Riemannian metric, r its Levi-Civita connection, J be any g{orthogonal almost-complex structure, and !(x;y) = hJx; yi its fundamental 2{form, then, for any vector elds x;z on M, we have:

$$(d!)(x;Jx;z) = [x;Jx]; Jz - r_x x + r_{Jx} Jx; z$$

For any 2{form we have:

$$(d)(x;y;z) = r_{x} (y;z) + r_{y} (z;x) + r_{z} (x;y)$$

$$= x (y;z) + y (z;x) + z (x;y)$$

$$- r_{x}y;z - r_{y}z;x - r_{z}x;y$$

$$- y;r_{x}z - z;r_{y}x - x;r_{z}y$$

Applying this to !(a;b) = hJa; bi, we have:

$$\begin{split} (d!)(x;Jx;z) &= -x \ x;z \ + (Jx) \ Jz; \ x \ + z \ Jx;Jx \\ &- \ Jr_{x}Jx; \ z \ - \ Jr_{Jx}z; \ x \ - \ Jr_{z}x;Jx \\ &+ \ x; \ r_{x}z \ - \ Jz; \ r_{Jx}x \ - \ Jx; \ r_{z}Jx \end{split}$$

Using that ha; Jbi = -hJa; bi we get:

Since  $r_z x$ ;  $x = \frac{1}{2}z$  x; x and Jx;  $r_z Jx = \frac{1}{2}z$  Jx;  $Jx = \frac{1}{2}z$  X; x, we cancel the last terms of each line, and get:

$$(d!)(x;Jx;z) = -x \ x;z + (Jx) \ Jz; x$$

$$+ \ r_x Jx; Jz + \ r_{Jx} z; Jx$$

$$+ \ x; r_x z - Jz; r_{Jx} x$$

But  $X X/Z = \Gamma_X X/Z + X/\Gamma_X Z$ , so  $(JX) JZ/X = -(JX) Z/JX = -\Gamma_{JX} Z/JX - Z/\Gamma_{JX} JX$ , and therefore:

$$\begin{split} (d!)(x;Jx;z) &= -r_{_X}x; \, z \, - \, x; \, r_{_X}z \, - \, r_{_{J_X}}z; \, Jx \, - \, z; \, r_{_{J_X}}Jx \\ &+ \, r_{_X}Jx; \, Jz \, + \, r_{_{J_X}}z; \, Jx \, + \, x; \, r_{_X}z \, - \, Jz; \, r_{_{J_X}}x \\ (d!)(x;Jx;z) &= -r_{_X}x; \, z \, - \, z; \, r_{_{J_X}}Jx \, + \, r_{_X}Jx; \, Jz \, - \, Jz; \, r_{_{J_X}}x \end{split}$$

Since r is torsion-free, we have  $r_x Jx - r_{Jx} x = [x; Jx]$ , so:

$$(d!)(X;JX;Z) = [X;JX];JZ - r_XX + r_{JX}JX;Z$$

which concludes the proof.

In particular, if ! is symplectic (i.e. d! = 0), then any integrable  $\mathcal{J}\{\text{holomorphic plane} \text{ eld is } g\{\text{minimal, and, vice-versa, any } g\{\text{minimal } \mathcal{J}\{\text{holomorphic plane} \text{ eld must be integrable.}$  The converse is also true: If there are enough  $\mathcal{J}\{\text{holomorphic integrable minimal plane} \text{ elds, then } !$  must be symplectic. Thus:

**Corollary 5.1** Assume that M admits two transversal 2 {dimensional foliations F and G such that: there is a metric g such that both F and G are g{minimal, and there is a g{orthogonal almost-complex structure J that makes both F and G be J{holomorphic. Then M admits the symplectic structure P(X;Y) = g(JX;Y).

In particular, if the  $\$ rst condition is satis ed, and further  $\$ F and  $\$ G are  $\$ g $\{$ orthogonal, then the second condition is automatically satis ed, and Proposition 3.11 follows:

If a Riemannian manifold M admits two  $g\{$ orthogonal and  $g\{$ minimal foliations, then M admits a symplectic structure.
